5	SECTION 1. Title 4, Health and Safety Code, is amended by
6	adding Subtitle D-1 before Chapter 288 as follows:
7	Subtitle D-1. PROVIDER PARTICIPATION PROGRAMS
8	SECTION 2. Chapter 289, Health and Safety Code, is deleted
9	and replaced by the following new Chapter 289 to read as follows:
10	CHAPTER 289. PROVISIONS OF GENERAL APPLICABILITY TO PROVIDER
11	PARTICIPATION PROGRAMS
12	Sec. 289.0001 PURPOSE. This chapter provides provisions
13	that apply to all provider participation programs in this Subtitle
14	D-1, including those operated by a county health care funding
15	district under Chapter 288.
16	Sec. 289.0101. BASIS FOR MANDATORY PAYMENTS.
17	Notwithstanding language elsewhere in this Subtitle D-1, a local
18	government administering a program under this subtitle may utilize
19	a basis other than the net patient revenue of each institutional
20	health care provider to compute the mandatory payments.
21	Specifically, a local government entity administering a program
22	under this subtitle may utilize any basis permitted by federal law
23	at 42 U.S.C. Section 1396b(w) and 42 C.F.R. Section 433.68.
24	Sec. 289.0102. DOCUMENTATION. If the documentation, that

1 is to be submitted by institutional health care providers to the 2 local government as specified elsewhere in this Subtitle D-1, is insufficient for a local government to assure that all 3 institutional health care providers are assessed a mandatory 4 payment that is consistent with this subtitle and federal law at 42 5 U.S.C. Section 1396b(w) and 42 C.F.R. Section 433.68, a local 6 7 government may require and use additional documentation to 8 effectuate that purpose. 9 Sec. 289.0103. AUTHORITY TO REQUEST WAIVER. If federal law 10 at 42 U.S.C. Section 1396b(w) or 42 C.F.R. Part 433 Subpart B is revised, or interpreted by the Centers for Medicare & Medicaid 11 12 Services, in ways that impede the operation of local provider participation programs, and a local government administering a 13 program under this subtitle determines that it would be beneficial 14 for the Health and Human Services Commission to obtain a waiver from 15 the Centers for Medicare & Medicaid Services as permitted by 42 16 17 U.S.C. Section 1396b(w)(3) and 42 C.F.R. Section 433.68(e), then the local government may request that the Commission submit such 18 waiver request. If a request is submitted to the Commission, the 19 Commission shall submit such waiver request to the Centers for 20 Medicare & Medicaid Services on behalf of the local government, 21 22 along with documentation justifying that waiver request provided by the local government. If the waiver request is granted, then the 23 24 local government, consistent with the terms of the waiver granted, need not comply with requirements elsewhere in this subtitle that 25 26 mandatory payments be assessed on each provider and that the amount

of the mandatory payment be uniformly proportionate with the amount

- 21 SECTION 7. Section 299.151(c), Health and Safety Code, is
- 22 amended to read as follows:

- 24 under this chapter, the board shall set the amount of the mandatory
- 25 payment, subject to the limitations of this chapter. The aggregate
- 26 amount of the mandatory payments required of all paying providers

- 1 net patient revenue from hospital services provided by all paying
- 2 providers in the district.
- 3 SECTION 8. This Act takes effect immediately if it receives
- 4 a vote of two-thirds of all the members elected to each house, as
- 5 provided by Section 39, Article III, Texas Constitution. If this
- 6 Act does not receive the vote necessary for immediate effect, this
- 7 Act takes effect September 1, 2021.
