(g-1) An offense under Subsection (e) [7 except that the 24

CONFORMING AMENDMENTS 4 5 SECTION 2.01. The heading to Chapter 110, Business & Commerce Code, is amended to read as follows: 6 CHAPTER 110. COMPUTER TECHNICIANS REQUIRED TO REPORT CHILD SEXUAL 7 8 ABUSE MATERIAL [PORNOCRAPHY] SECTION 2.02. Section 110.001(1), Business & Commerce Code, 9 is amended to read as follows: 10 (1) "Child <u>sexual abuse material</u> [pornography]" means 11 12 an image of a child engaging in sexual conduct or sexual 13 performance. SECTION 2.03. The heading to Section 110.002, Business & 14 15 Commerce Code, is amended to read as follows: 16 Sec. 110.002. REPORTING OF IMAGES OF CHILD SEXUAL ABUSE 17 MATERIAL [PORNOGRAPHY]. SECTION 2.04. Sections 110.002(a) and (c), Business 18 & Commerce Code, are amended to read as follows: 19 (a) A computer technician who, in the course and scope of 20 employment or business, views an image on a computer that is or 21 appears to be child sexual abuse material [pornography] shall 22 immediately report the discovery of the image to a local or state 23 24 law enforcement agency or the Cyber Tipline at the National Center for Missing and Exploited Children. The report must include the 25 26 name and address of the owner or person claiming a right to possession of the computer, if known, and as permitted by federal 27

1 law.

2 (c) A telecommunications provider, commercial mobile 3 service provider, or information service provider may not be held 4 liable under this chapter for the failure to report child <u>sexual</u> 5 <u>abuse material</u> [pornography] that is transmitted or stored by a 6 user of the service.

7 SECTION 2.05. Section 110.003(b), Business & Commerce Code, 8 is amended to read as follows:

9 (b) It is a defense to prosecution under this section that 10 the actor did not report the discovery of an image of child <u>sexual</u> 11 <u>abuse material</u> [<del>pornography</del>] because the child in the image 12 appeared to be at least 18 years of age.

13 SECTION 2.06. Articles 18.18(a), (b), (e), (f), (g), and 14 (h), Code of Criminal Procedure, are amended to read as follows:

15 (a) Following the final conviction of a person for possession of a gambling device or equipment, altered gambling 16 17 equipment, or gambling paraphernalia, for an offense involving a criminal instrument, for an offense involving an obscene device or 18 material, for an offense involving child sexual abuse material 19 [pornography], or for an offense involving a scanning device or 20 re-encoder, the court entering the judgment of conviction shall 21 order that the machine, device, gambling equipment or gambling 22 23 paraphernalia, instrument, obscene device or material, child 24 sexual abuse material [pornography], or scanning device or re-encoder be destroyed or forfeited to the state. Not later than 25 26 the 30th day after the final conviction of a person for an offense 27 involving a prohibited weapon, the court entering the judgment of

1 conviction on its own motion, on the motion of the prosecuting attorney in the case, or on the motion of the law enforcement agency 2 3 initiating the complaint on notice to the prosecuting attorney in the case if the prosecutor fails to move for the order shall order 4 5 that the prohibited weapon be destroyed or forfeited to the law enforcement agency that initiated the complaint. If the court fails 6 to enter the order within the time required by this subsection, any 7 8 magistrate in the county in which the offense occurred may enter the order. Following the final conviction of a person for an offense 9 10 involving dog fighting, the court entering the judgment of conviction shall order that any dog-fighting equipment be destroyed 11 12 or forfeited to the state. Destruction of dogs, if necessary, must be carried out by a veterinarian licensed in this state or, if one 13 14 is not available, by trained personnel of a humane society or an 15 animal shelter. If forfeited, the court shall order the contraband delivered to the state, any political subdivision of the state, or 16 17 to any state institution or agency. If gambling proceeds were seized, the court shall order them forfeited to the state and shall 18 19 transmit them to the grand jury of the county in which they were seized for use in investigating alleged violations of the Penal 20 Code, or to the state, any political subdivision of the state, or to 21 22 any state institution or agency.

(b) If there is no prosecution or conviction following seizure, the magistrate to whom the return was made shall notify in writing the person found in possession of the alleged gambling device or equipment, altered gambling equipment or gambling paraphernalia, gambling proceeds, prohibited weapon, obscene

device or material, child sexual abuse material [pornography], 1 device re-encoder, criminal instrument, scanning 2 or or 3 dog-fighting equipment to show cause why the property seized should not be destroyed or the proceeds forfeited. The magistrate, on the 4 5 motion of the law enforcement agency seizing a prohibited weapon, shall order the weapon destroyed or forfeited to the 6 law enforcement agency seizing the weapon, unless a person shows cause 7 8 as to why the prohibited weapon should not be destroyed or forfeited. A law enforcement agency shall make a motion under this 9 10 subsection [section] in a timely manner after the time at which the agency is informed in writing by the attorney representing the 11 state that no prosecution will arise from the seizure. 12

Any person interested in the alleged gambling device or 13 (e) 14 equipment, altered gambling equipment or gambling paraphernalia, 15 gambling proceeds, prohibited weapon, obscene device or material, child sexual abuse material [pornography], scanning device or 16 17 re-encoder, criminal instrument, or dog-fighting equipment seized must appear before the magistrate on the 20th day following the date 18 19 the notice was mailed or posted. Failure to timely appear forfeits any interest the person may have in the property or proceeds seized, 20 and no person after failing to timely appear may contest 21 destruction or forfeiture. 22

(f) If a person timely appears to show cause why the property or proceeds should not be destroyed or forfeited, the magistrate shall conduct a hearing on the issue and determine the nature of property or proceeds and the person's interest therein. Unless the person proves by a preponderance of the evidence that the

1 property or proceeds is not gambling equipment, altered gambling equipment, gambling paraphernalia, gambling device, gambling 2 3 proceeds, prohibited weapon, obscene device or material, child sexual abuse material [pornography], criminal instrument, scanning 4 5 device or re-encoder, or dog-fighting equipment and that the person [he] is entitled to possession, the magistrate shall dispose of the 6 property or proceeds in accordance with Subsection [Paragraph] (a) 7 8 [of this article].

No provider of an electronic communication service or of 13 (h) 14 a remote computing service to the public shall be held liable for an 15 offense involving obscene material or child sexual abuse material [pornography] under this article [section] on account of any action 16 17 taken in good faith in providing that service.
