Section 3.005(a), Business Organizations Code, 5 is amended to read as follows: 6 The certificate of formation must state: 7 (a) (1) the name of the filing entity being formed; 8 the type of filing entity being formed; 9 (2) (3) for filing entities other limited 10 than partnerships, the purpose or purposes for which the filing entity 11 12 is formed, which may be stated to be or include any lawful purpose for that type of entity; 13 14 (4) for filing entities other than limited partnerships, the period of duration, if the entity is not formed to 15 exist perpetually and is intended to have a specific period of 16 duration; 17 (5) the street address of the initial registered 18 office of the filing entity and the name of the initial registered 19 agent of the filing entity at the office; 20 21 (6) the initial mailing address of the filing entity; 22 (7) the name and address of each: organizer for the filing entity, unless the 23 (A) 24 entity is formed under a plan of conversion or merger;

3 (C) trust manager, if the filing entity is a real
4 estate investment trust;

5 (8) [(7)] if the filing entity is formed under a plan 6 of conversion or merger, a statement to that effect and, if formed 7 under a plan of conversion, the name, address, date of formation, 8 prior form of organization, and jurisdiction of formation of the 9 converting entity; and

10 <u>(9)</u> [<del>(8)</del>] any other information required by this code 11 to be included in the certificate of formation for the filing 12 entity.

13 SECTION 2. The change in law made by this Act applies only 14 to a certificate of formation filed on or after the effective date 15 of this Act. A certificate of formation filed before the effective 16 date of this Act is governed by the law in effect on the date on 17 which the certificate of formation was filed, and the former law is 18 continued in effect for that purpose.

19 SECTION 3. This Act takes effect January 1, 2022.
