17	registration as the defendant; and
18	(3) practices in the area of practice of the defendant

2 (i) A claimant is not required to file an affidavit described by Subsection (a) if the action or arbitration proceeding 3 4 arises out of a design-build project in which a governmental entity contracts with a single entity to provide both design and 5 6 construction services for the construction, expansion, extension, rehabilitation, alteration, or repair of a facility, a building or 7 associated structure, a civil works project, or a highway project. 8 9 SECTION 2. The change in law made by this Act applies only to an action commenced on or after the effective date of this Act. 10 An action commenced before the effective date of this Act is 11 governed by the law as it existed immediately before the effective 12 date of this Act, and that law is continued in effect for that 13 14 purpose.

15 SECTION 3. This Act takes effect September 1, 2021.
