- 18 (g) The provisions for conducting a local option election
- 19 under Chapter 501, Election Code, apply to an election conducted
- 20 under this section to the extent those provisions do not conflict
- 21 with this section.
- (h) The results of an election conducted under this section
- 23 do not affect the legal sale of one or more types or classifications
- 24 of alcoholic beverages that are permitted in the zone because of the
- 25 zone's inclusion in a political subdivision.
- 26 SECTION 2. This Act takes effect September 1, 2021.
