4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle D, Title 4, Government Code, is amended
6	by adding Chapter 448 to read as follows:
7	CHAPTER 448. TEXAS HOLOCAUST, GENOCIDE, AND ANTISEMITISM ADVISORY
8	COMMISSION
9	SUBCHAPTER A. GENERAL AND ADMINISTRATIVE PROVISIONS
10	Sec. 448.001. DEFINITIONS. In this chapter:
11	(1) "Advisory commission" means the Texas Holocaust,
12	Genocide, and Antisemitism Advisory Commission.
13	(2) "Antisemitism" means a certain perception of Jews
14	that may be expressed as hatred toward Jews. The term includes
15	rhetorical and physical acts of antisemitism directed toward Jewish
16	or non-Jewish individuals or their property or toward Jewish
17	community institutions and religious facilities. Examples of
18	antisemitism are included with the International Holocaust
19	Remembrance Alliance's "Working Definition of Antisemitism"
20	adopted on May 26, 2016.
21	(3) "Commission" means the Texas Historical
22	Commission.
23	(4) "Genocide" means any of the following acts
24	committed with intent to wholly or partly destroy a national,

1	ethnic, racial, or religious group:		
2	(A) killing members of the group;		
3	(B) causing serious bodily or mental harm to		
4	members of the group;		
5	(C) deliberately inflicting on the group		
6	conditions of life calculated to wholly or partly cause the group's

8	(D) imposing measures intended to prevent births		
9	within the group; or		
10	(E) forcibly transferring children of the group		
11	to another group.		
12	(5) "Holocaust" means the killing of approximately six		
13	million Jews and millions of other persons during World War II by		
14	the National Socialist German Workers' Party (Nazis) and Nazi		
15	collaborators as part of a state-sponsored, systematic program of		
16	genocide and other acts of persecution, discrimination, violence,		
17	or other human rights violations committed by the Nazis and Nazi		
18	collaborators against those persons.		
19	Sec. 448.002. SUNSET REVIEW. The advisory commission shall		
20	be reviewed during the period in which the Texas Historical		
21	Commission is reviewed under Chapter 325.		
22	Sec. 448.003. ADVISORY COMMISSION. The Texas Holocaust,		
23	Genocide, and Antisemitism Advisory Commission is established as an		
24	advisory commission to the commission.		
25	SUBCHAPTER B. TEXAS HOLOCAUST, GENOCIDE, AND ANTISEMITISM ADVISORY		
26	COMMISSION		
27	Sec. 448.051. COMPOSITION OF ADVISORY COMMISSION. (a) The		

- 1 governor shall appoint nine members to the advisory commission.
- 2 (b) A member of the advisory commission must be a resident
- 3 of this state.
- 4 (c) The advisory commission must include members who:
- 5 (1) have demonstrated a significant interest in and
- 6 are knowledgeable about issues in the Jewish community and
- 7 <u>antisemitism;</u>
- 8 (2) have served prominently as leaders of or
- 9 spokespersons for public or private organizations that serve
- 10 members of religious, ethnic, national heritage, or social groups
- 11 that were subjected to antisemitism, the Holocaust, or other
- 12 genocides;
- 13 (3) have significant professional experience in the
- 14 field of Holocaust or genocide education;
- 15 (4) represent liberators of Holocaust or other
- 16 genocide victims; or
- 17 (5) have demonstrated a significant, particular
- 18 interest in Holocaust or genocide education.
- 19 (d) The governor shall fill any vacancy in a position on the
- 20 advisory commission for the unexpired portion of the term.
- 21 <u>Sec. 448.052. TERMS. (a) Advisory commission members</u>
- 22 serve staggered six-year terms with the terms of three members
- 23 expiring February 1 of each odd-numbered year.
- 24 (b) An advisory commission member is eligible for
- 25 reappointment to another term or part of a term.
- 26 (c) An advisory commission member may not serve more than
- 27 two consecutive terms. For purposes of this subsection, a member is

- 1 considered to have served a term only if the member served two or
- 2 more years of the member's term.
- 3 <u>Sec. 448.053. PRESIDING OFFICER. The governor shall</u>
- 4 designate a member of the advisory commission as presiding officer
- 5 of the advisory commission to serve in that capacity at the pleasure
- 6 of the governor.
- 7 <u>Sec. 448.054.</u> SUBCOMMITTEES. The presiding officer of the
- 8 advisory commission may appoint a subcommittee for any purpose
- 9 consistent with the duties of the advisory commission under this
- 10 chapter.
- Sec. 448.055. COMPENSATION; EXPENSES. A member of the
- 12 advisory commission is not entitled to compensation but is entitled
- 13 to reimbursement for the travel expenses incurred by the member
- 14 while transacting advisory commission business, as provided by the
- 15 General Appropriations Act.
- Sec. 448.056. MEETINGS; QUORUM; PUBLIC ACCESS. (a) The
- 17 advisory commission shall meet at least quarterly at the times and
- 18 places in this state the commission designates.
- 19 (b) Five voting members of the advisory commission
- 20 constitute a quorum for transacting advisory commission business.
- 21 (c) The commission shall develop and implement policies
- 22 that provide the public with a reasonable opportunity to appear
- 23 before the advisory commission and speak on any issue under the
- 24 jurisdiction of the advisory commission.
- Sec. 448.057. TRAINING. Each member of the advisory
- 26 commission shall complete the training program prescribed by the
- 27 commission. The program must provide the member with information

1 on: 2 (1) the role and duties of advisory commission 3 members; 4 (2) the functions of the advisory commission; and (3) 5 the commission's oversight of the advisory commission. 6 Sec. 448.058. PERSONNEL. The commission shall: 7 (1) hire personnel as necessary to support the 8 advisory commission in fulfilling its duties under this chapter, 9 including establishing staffing levels, position titles, and 10 salaries of the employees and managing and evaluating the 11 12 employees; and (2) provide other administrative support to the 13 advisory commission as necessary. 14 15 SUBCHAPTER C. POWERS AND DUTIES OF COMMISSION AND ADVISORY 16 COMMISSION; FUNDING 17 Sec. 448.101. DUTIES OF ADVISORY COMMISSION. (a) The advisory commission, under direction of the commission, shall: 18 19 (1) conduct a study on antisemitism in this state and submit a report on the results of the study to the governor, the 20 lieutenant governor, the speaker of the house of representatives, 21 and each member of the legislature not later than November 1 of each 22 23 even-numbered year; 24 (2) provide advice and assistance to public and private primary and secondary schools and institutions of higher 25 26 education in this state regarding methods of combating antisemitism and implementation of Holocaust and genocide courses of study and 27

- 1 <u>awareness programs;</u>
- 2 (3) meet with appropriate representatives of public
- 3 and private organizations, including service organizations, to
- 4 provide information on and to assist in planning, coordinating, or
- 5 modifying antisemitism awareness programs and Holocaust and
- 6 genocide courses of study and awareness programs;
- 7 (4) compile a list of volunteers, such as Holocaust or
- 8 other genocide survivors, liberators of concentration camps,
- 9 scholars, and members of the clergy, who have agreed to share, in
- 10 classrooms, seminars, exhibits, or workshops, their verifiable
- 11 knowledge and experiences regarding the Holocaust or other
- 12 genocide;
- 13 (5) annually coordinate events in this state
- 14 memorializing the Holocaust and other genocides on January 27,
- 15 <u>International Holocaust Remembrance Day, on the Days of Remembrance</u>
- 16 <u>established</u> by the United States Congress, or on any other day
- 17 designated by the advisory commission for that purpose;
- 18 (6) solicit volunteers to participate in
- 19 commemorative events designed to enhance public awareness of the
- 20 fight against antisemitism and continuing significance of the
- 21 Holocaust and other genocides;
- 22 (7) collaborate with appropriate groups to support
- 23 efforts to recognize International Holocaust Remembrance Day; and
- 24 (8) make recommendations as to whether International
- 25 Holocaust Remembrance Day shall be a state holiday.
- 26 (b) In implementing Subsection (a), the advisory
- 27 commission, under direction of the commission, may contact and

- 1 cooperate with:
- 2 (1) existing public or private antisemitism,
- 3 Holocaust, or other genocide resource organizations, including the
- 4 United States Holocaust Memorial Museum;
- 5 (2) other museums, centers, and organizations based in
- 6 this state;
- 7 (3) state agencies that perform this state's
- 8 educational functions as delegated under the Education Code,
- 9 including the Texas Education Agency and the Texas Higher Education
- 10 Coordinating Board;
- 11 (4) the Texas Veterans Commission; and
- 12 (5) members of the United States Congress and of the
- 13 legislature of this state.
- 14 (c) The commission may provide matching grants to assist in
- 15 the implementation of the advisory commission's goals and
- 16 objectives.
- 17 (d) Chapter 2110 does not apply to the advisory commission.
- 18 Sec. 448.102. COMMISSION POWERS AND DUTIES. (a) The
- 19 commission shall adopt rules as necessary governing the operation
- 20 of the advisory commission. The rules may include the delegation of
- 21 certain final decisions and authorities to the advisory commission
- 22 that are appropriate given the advisory commission's advisory
- 23 status.
- 24 (b) The commission, in coordination with the advisory
- 25 commission, shall adopt rules, policies, and procedures for the
- 26 matching grants program established to assist in the implementation
- 27 of the goals and objectives of this chapter. The commission must

- 1 prescribe for the program an annual budget, a funding cycle, goals,
- 2 award eligibility criteria, grant application and selection
- 3 processes, requirements for in-kind services and matching fund
- 4 waivers, maximum grant awards, conflict of interest policies, data
- 5 collection and evaluation, and audits of grant recipients.
- 6 Sec. 448.103. FUNDING. (a) The commission may accept gifts
- 7 and grants from a public or private source on behalf of the advisory
- 8 commission for the advisory commission to use in performing the
- 9 duties assigned to the advisory commission under this chapter.
- 10 (b) All legislative appropriations to support the functions
- 11 and activities of the advisory commission shall be made as part of
- 12 the commission's legislative appropriations request process and
- 13 disbursed to the commission.
- 14 Sec. 448.104. COMMISSION REPORT; AUDITS. (a) The
- 15 commission shall include the activities of the advisory commission
- 16 <u>as authorized by Section 448.101 in the report the commission is</u>
- 17 required to submit under Section 442.005(n).
- 18 (b) The advisory commission is subject to audit and
- 19 evaluation by the commission or another appropriate state agency,
- 20 including the state auditor's office.
- Sec. 448.105. CONTRACTS WITH NONPROFIT ORGANIZATIONS. (a)
- 22 The commission may contract with one or more nonprofit
- 23 organizations to assist in fulfilling the advisory commission's
- 24 duties under this chapter.
- 25 (b) The commission shall adopt rules relating to contracts
- 26 entered into under this section. The rules must require each
- 27 contract to clearly establish:

- 1 (1) the role of the nonprofit organization in
- 2 assisting the advisory commission in fulfilling its duties under
- 3 this chapter;
- 4 (2) the nature of the relationship between the
- 5 commission and the nonprofit organization;
- 6 (3) the performance expectations for the nonprofit
- 7 <u>organization;</u>
- 8 <u>(4) requirements and expectations regarding the</u>
- 9 nonprofit organization's employees;
- 10 (5) the commission's expectations regarding ownership
- 11 of any literature, media, or other products developed or produced
- 12 by the nonprofit organization to assist the advisory commission in
- 13 fulfilling its duties under this chapter;
- 14 (6) the commission's long-term goals for the advisory
- 15 <u>commission and the nonprofit organization's role in meeting those</u>
- 16 goals;
- 17 (7) a system for evaluating the nonprofit
- 18 organization's overall performance, including the organization's
- 19 effectiveness in meeting the performance expectations described by
- 20 Subdivision (3); and
- 21 (8) the types of support, other than financial
- 22 support, the commission will provide to the nonprofit organization
- 23 to assist in the fulfillment of the advisory commission's duties.
- SECTION 2. Section 29.9072(c), Education Code, is amended
- 25 to read as follows:
- 26 (c) Holocaust Remembrance Week shall include
- 27 age-appropriate instruction, as determined by each school

- 1 district. Instruction shall include:
- 2 (1) information about the history of and lessons
- 3 learned from the Holocaust;
- 4 (2) participation, in person or using technology, in
- 5 learning projects about the Holocaust; and
- 6 (3) the use of materials developed or approved by the
- 7 Texas Holocaust, [and] Genocide, and Antisemitism Advisory
- 8 Commission.
- 9 SECTION 3. Chapter 449, Government Code, is repealed.
- 10 SECTION 4. (a) As soon as practicable after the effective
- 11 date of this Act, the governor shall appoint members to the vacant
- 12 positions on the Texas Holocaust, Genocide, and Antisemitism
- 13 Advisory Commission as provided by Chapter 448, Government Code, as
- 14 added by this Act. To implement the staggering of terms of members
- of the advisory commission provided by Section 448.052, Government
- 16 Code, as added by this Act, in making the first appointments to the
- 17 advisory commission, the governor shall provide for three of the
- 18 members to serve terms expiring February 1, 2023, three of the
- 19 members to serve terms expiring February 1, 2025, and three of the
- 20 members to serve terms expiring February 1, 2027. Subsequent
- 21 appointments shall be for six-year terms, as provided by Section
- 22 448.052, Government Code, as added by this Act.
- (b) Members who have served two terms under the former Texas
- 24 Holocaust and Genocide Commission are not eligible for appointment
- 25 under the Texas Holocaust, Genocide, and Antisemitism Advisory
- 26 Commission.
- (c) Section 448.057, Government Code, as added by this Act,

- 1 applies to a member of the Texas Holocaust, Genocide, and
- 2 Antisemitism Advisory Commission appointed before, on, or after the
- 3 effective date of this Act.
- 4 SECTION 5. (a) Not later than December 1, 2022, the Texas
- 5 Historical Commission and the Texas Holocaust, Genocide, and
- 6 Antisemitism Advisory Commission shall provide a written report to
- 7 the Sunset Advisory Commission on the progress of the Texas
- 8 Historical Commission and the Texas Holocaust, Genocide, and
- 9 Antisemitism Advisory Commission in implementing the changes in law
- 10 made by this Act. The report must identify any obstacles or
- 11 concerns encountered in implementing the changes.
- 12 (b) All contracts and agreements of the former Texas
- 13 Holocaust and Genocide Commission are continued in effect as
- 14 contracts and agreements of the Texas Historical Commission.
- 15 (c) The Texas Historical Commission shall coordinate with
- 16 the Texas Holocaust, Genocide, and Antisemitism Advisory
- 17 Commission and the Legislative Budget Board to propose goals,
- 18 strategies, and performance measures for the advisory commission in
- 19 the commission's legislative appropriations request for the state
- 20 fiscal biennium ending August 31, 2025.
- 21 SECTION 6. As soon as practicable after the effective date
- 22 of this Act, the Texas Historical Commission shall perform an
- 23 evaluation of the job titles and salaries of personnel employed by
- 24 the commission to support the Texas Holocaust, Genocide, and
- 25 Antisemitism Advisory Commission under Section 448.058, Government
- 26 Code, as added by this Act, in order to ensure that the salaries and
- 27 titles are commensurate with other commission employees with

- 1 comparable duties.
- 2 SECTION 7. This Act takes effect September 1, 2021.
