## A BILL TO BE ENTITLED 1 AN ACT 2 relating to the authority of a district engineer for the Texas Department of Transportation to temporarily lower the speed limit 3 at a highway maintenance activity site. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 SECTION 1. Subchapter H, Chapter 545, Transportation Code, 6 7 is amended by adding Section 545.3531 to read as follows: Sec. 545.3531. AUTHORITY OF DISTRICT ENGINEER TO 8 TEMPORARILY LOWER SPEED LIMIT AT HIGHWAY MAINTENANCE ACTIVITY SITE. 9 (a) A district engineer may temporarily lower a prima facie speed 10 11 limit for a highway or part of a highway in a district if the 12 district engineer determines that the prima facie speed limit for the highway or part of highway is unreasonable or unsafe because of 13 14 highway maintenance activities at the site. 15 (b) A district engineer may temporarily lower a prima facie speed limit under this section without the approval of or 16 permission from the Texas Transportation Commission. 17 18 (c) A temporary speed limit established under this section: (1) is a prima facie prudent and reasonable speed 19 limit enforceable in the same manner as other prima facie speed 20 21 limits established under other provisions of this subchapter; and 22 (2) supersedes any other established speed limit that 23 would permit a person to operate a motor vehicle at a higher rate of 24 speed.

No. 3282 1 (d) A district engineer who temporarily lowers a speed limit 2 under this section shall: 3 (1) place and maintain at the maintenance activity site temporary speed limit signs that conform to the manual and 4 5 specifications adopted under Section 544.001; 6 (2) temporarily conceal all other signs on the highway or part of a highway affected by the maintenance activity that give 7 8 notice of a speed limit that would permit a person to operate a motor vehicle at a higher rate of speed; and 9 10 (3) remove all temporary speed limit signs placed under Subdivision (1) and concealments of other signs placed under 11 12 Subdivision (2) when: (A) the district engineer determines that the 13 14 maintenance activity has been completed and all equipment has been 15 removed from the maintenance activity site; or 16 (B) the temporary speed limit expires under 17 Subsection (f). (e) A temporary speed limit established under this section 18 is effective when the district engineer, as required under 19 Subsection (d), places temporary speed limit signs and conceals 20 other signs that would permit a person to operate a motor vehicle at 21 22 a higher rate of speed. 23 (f) A temporary speed limit established under this section: 24 (1) is effective until the 30th day after the date the limit becomes effective; and 25 26 (2) may not be extended unless established by the Texas Transportation Commission under Section 545.353. 27

1 SECTION 2. This Act takes effect immediately if it receives 2 a vote of two-thirds of all the members elected to each house, as 3 provided by Section 39, Article III, Texas Constitution. If this 4 Act does not receive the vote necessary for immediate effect, this 5 Act takes effect September 1, 2021.
