Section 13.007, Election Code, is amended by 6 7 amending Subsections (a), (b) and (c) to read as follows: 8 (a) A person commits an offense if the person: (1) knowingly makes a false statement; or 9 (2) requests, commands, coerces, or attempts to induce 10 another person to make a false statement on a registration 11 12 application. 13 (b) An offense under this section is a Class B misdemeanor. 14 (C) If conduct that constitutes an offense under this section also constitutes an offense under another law, the actor 15 may be prosecuted under this section, the other law, or both [For 16 purposes of this code, an offense under this section is considered 17 to be perjury, but may be prosecuted only under this section]. 18 SECTION 2. Section 64.012, Election Code, is amended by 19 amending Subsection (a) and adding Subsection (c) to read as 20 21 follows: 22 A person commits an offense if the person: (a) 23 (1) votes or attempts to vote in an election in which 24 the person knows the person is not eligible to vote;

(a) A person commits an offense if, with the intent to deceive, the person makes a false statement or swears to the truth 25 26 of a false statement: 27 (1) on a registration application; or

(2) previously made while taking an oath, or making a
declaration or affidavit prescribed by this code.

3 (b) An offense under this section is a state jail felony.

4 SECTION 5. The change in law made by this Act applies only to an offense committed on or after the effective date of this Act. 5 An offense committed before the effective date of this Act is 6 governed by the law in effect on the date the offense was committed, 7 and the former law is continued in effect for that purpose. 8 For purposes of this section, an offense was committed before the 9 effective date of this Act if any element of the offense occurred 10 before that date. 11
