C.S.H.B. No. 3351

A BILL TO BE ENTITLED

AN ACT

relating to establishing the Texas Commission on Community College
Finance.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subchapter G, Chapter 130, Education Code, is
amended by adding Section 130.1305 to read as follows:

Sec. 130.1305. TEXAS COMMISSION ON COMMUNITY COLLEGE
FINANCE. (a) The Texas Commission on Community College Finance is
established to make recommendations for consideration by the 88th
Texas Legislature regarding the state funding formula and funding
levels for public junior colleges in Texas that would be sufficient
to sustain viable junior college education and training offerings
throughout the state and improve student outcomes in alignment with
state postsecondary goals.

(b) The commission is composed of 12 members as follows:

(1) four members appointed by the governor;

(2) three members appointed by the lieutenant
governor;

(3) three members appointed by the speaker of the
house of representatives;

(4) one member appointed by the board of the Texas
Association of Community Colleges; and

(5) one member appointed by the board of the Community
College Association of Texas Trustees.

1 (c) One of the members appointed by the governor must be a
2 faculty member at a public junior college as defined by Section
3 61.003, and the other members appointed by the governor must be
4 representatives of junior college leaders, business leaders, or
5 other stakeholders knowledgeable in junior college mission,
6 instructional programs, and finance.

7 (d) Members appointed by the lieutenant governor shall
8 consist of:

9 (1) two members of the senate; and

10 (2) an administrator from a public junior college as
11 defined by Section 61.003.

12 (e) Members appointed by the speaker of the house of
13 representatives shall consist of:

14 (1) two members of the house of representatives; and

15 (2) an administrator from a public junior college as
16 defined by Section 61.003.

17 (f) In making appointments, the governor, lieutenant
18 governor, and speaker of the house of representatives shall
19 coordinate to ensure that the membership of the commission
20 reflects, to the extent possible, the geographic diversity of Texas
21 public junior colleges and the ethnic diversity of the communities
22 served by those junior colleges.

23 (g) The commission shall convene not later than October 15,
24 2021, and shall continue its activities until completion of a final
25 report.

26 (h) The commission shall examine trend and forecast data,
27 seek stakeholder input, and account for equity in student outcomes

1 and based on its findings, make recommendations on:

2 (1) the components of state funding for public junior
3 colleges, including contact hour funding formulas established for
4 public junior colleges under Subchapter C, Chapter 61, and
5 Subchapter A of this chapter; and

6 (2) the feasibility of establishing shared service
7 agreements or interinstitutional collaborations through which
8 institutions of higher education may perform administrative
9 services, other than direct instruction and student support
10 services, for other institutions of higher education for a fee or
11 other consideration.

12 (i) The commission may seek resource support, including
13 data analyses and technical assistance, from the Texas Higher
14 Education Coordinating Board, the Texas Association of Community
15 Colleges, and research organizations. The commission may accept
16 gifts, grants, and donations from any source to be used to carry out
17 a function of the commission.

18 (j) The commission shall submit a final report and
19 recommendations to the governor, lieutenant governor, and both
20 houses of the legislature not later than November 1, 2022.

21 (k) This section expires January 1, 2023.

22 SECTION 2. This Act takes effect September 1, 2021.
