- 14 (2) contract payments described by Section 7901.0403.
- 15 (b) The district must hold an election in the manner

- 19 (c) The district may not issue bonds payable from ad valorem

- Sec. 7901.0402. OPERATION AND MAINTENANCE TAX. (a) If
- 24 authorized at an election held under Section 7901.0401, the
- 25 district may impose an operation and maintenance tax on taxable
- 26 property in the district in accordance with Section 49.107, Water
- 27 Code.

- 1 (b) The board shall determine the tax rate. The rate may not
- 2 exceed the rate approved at the election.
- 3 Sec. 7901.0403. CONTRACT TAXES. (a) In accordance with
- 4 Section 49.108, Water Code, the district may impose a tax other than
- 5 an operation and maintenance tax and use the revenue derived from
- 6 the tax to make payments under a contract after the provisions of
- 7 the contract have been approved by a majority of the district voters
- 8 voting at an election held for that purpose.
- 9 (b) A contract approved by the district voters may contain a
- 10 provision stating that the contract may be modified or amended by

- Sec. 7901.0501. AUTHORITY TO ISSUE BONDS AND OTHER

- 16 revenue, contract payments, grants, or other district money, or any
- 17 combination of those sources, to pay for any authorized district

- 19 Sec. 7901.0502. TAXES FOR BONDS. At the time the district
- 20 issues bonds payable wholly or partly from ad valorem taxes, the
- 21 board shall provide for the annual imposition of a continuing
- 22 direct ad valorem tax, without limit as to rate or amount, while all
- 23 or part of the bonds are outstanding as required and in the manner
- 24 provided by Sections 54.601 and 54.602, Water Code.
- Sec. 7901.0503. BONDS FOR ROAD PROJECTS. At the time of
- 26 issuance, the total principal amount of bonds or other obligations
- 27 issued or incurred to finance road projects and payable from ad

- 1 valorem taxes may not exceed one-fourth of the assessed value of the
- 2 real property in the district.
- 3 SECTION 2. Waller County Municipal Utility District No. 40

- (c) The Texas Commission on Environmental Quality has filed
- 25 its recommendations relating to this Act with the governor, the
- 26 lieutenant governor, and the speaker of the house of
- 27 representatives within the required time.

- 1 (d) All requirements of the constitution and laws of this
- 2 state and the rules and procedures of the legislature with respect
- 3 to the notice, introduction, and passage of this Act are fulfilled
- 4 and accomplished.
- 5 SECTION 4. (a) If this Act does not receive a two-thirds
- 6 vote of all the members elected to each house, Subchapter C, Chapter
- 7 7901, Special District Local Laws Code, as added by Section 1 of
- 8 this Act, is amended by adding Section 7901.0307 to read as follows:
- 9 Sec. 7901.0307. NO EMINENT DOMAIN POWER. The district may
- 10 not exercise the power of eminent domain.
- 11 (b) This section is not intended to be an expression of a
- 12 legislative interpretation of the requirements of Section 17(c),
- 13 Article I, Texas Constitution.
- 14 SECTION 5. This Act takes effect immediately if it receives
- 15 a vote of two-thirds of all the members elected to each house, as
- 16 provided by Section 39, Article III, Texas Constitution. If this
- 17 Act does not receive the vote necessary for immediate effect, this
- 18 Act takes effect September 1, 2021.
