- Sec. 411.301. DYNAMIC MESSAGE SIGNS. (a) Except as
- 13 provided by Subsection (c), the Texas Department of Transportation
- 14 shall enter into an agreement with a private entity to provide
- 15 information necessary for statewide alert systems created under
- 16 Subchapters L, M, P, P-1, and Q as added by Chapter 227 (H.B. 1769),
- 17 Acts of the 86th Legislature, Regular Session, 2019, through a
- 18 system of dynamic message signs that are:
- 19 <u>(1) located across the state; and</u>
- 20 (2) capable of displaying digital images useful in
- 21 <u>locating the missing individual.</u>
