## A BILL TO BE ENTITLED

2	relating to identification requirements for early voting by mail.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Section $84.001(c)$ , Election Code, is amended to
5	read as follows:
6	(c) An applicant <u>must</u> [ <del>is not required to</del> ] use an official
7	application form described by Section 84.011.
8	SECTION 2. Section 84.002(a), Election Code, is amended to
9	read as follows:
10	(a) An early voting ballot application must include:
11	(1) the applicant's name and the address at which the
12	applicant is registered to vote;
13	(1-a) the following information:
14	(A) the number of the applicant's election
15	identification certificate or unexpired driver's license or
16	personal identification card issued by the Department of Public
17	Safety;
18	(B) the applicant's voter registration number;
19	(C) the number of the applicant's unexpired
20	United States passport; or
21	(D) the applicant's social security number;
22	(2) for an application for a ballot to be voted by mail
23	on the ground of absence from the county of residence, the address
24	outside the applicant's county of residence to which the ballot is

- 1 to be mailed;
- 2 (3) for an application for a ballot to be voted by mail
- 3 on the ground of age or disability, the address of the hospital,
- 4 nursing home or other long-term care facility, or retirement
- 5 center, or of a person related to the applicant within the second
- 6 degree by affinity or the third degree by consanguinity, as
- 7 determined under Chapter 573, Government Code, if the applicant is
- 8 living at that address and that address is different from the
- 9 address at which the applicant is registered to vote;
- 10 (4) for an application for a ballot to be voted by mail
- 11 on the ground of confinement in jail, the address of the jail or of a
- 12 person related to the applicant within the degree described by
- 13 Subdivision (3);
- 14 (5) for an application for a ballot to be voted by mail
- 15 on any ground, an indication of each election for which the
- 16 applicant is applying for a ballot; and
- 17 (6) an indication of the ground of eligibility for
- 18 early voting.
- 19 SECTION 3. Section 84.011(a), Election Code, is amended to
- 20 read as follows:
- 21 (a) The officially prescribed application form for an early
- 22 voting ballot must include:
- 23 (1) immediately preceding the signature space the
- 24 statement: "I certify that the information given in this
- 25 application is true, and I understand that giving false information
- 26 in this application is a crime.";
- 27 (2) a statement informing the applicant of the

- 1 offenses prescribed by Sections 84.003 and 84.004;
- 2 (3) a space [spaces] for entering an applicant's
- 3 [voter registration number and] county election precinct of
- 4 registration, with a statement informing the applicant that failure
- 5 to furnish that information does not invalidate the application;
- 6 (3-a) a space for entering the information required
- 7 under Section 84.002(a)(1-a); and
- 8 (4) on an application for a ballot to be voted by mail:
- 9 (A) a space for an applicant applying on the
- 10 ground of absence from the county of residence to indicate the date
- 11 on or after which the applicant can receive mail at the address
- 12 outside the county;
- 13 (B) a space for indicating the fact that an
- 14 applicant whose application is signed by a witness cannot make the
- 15 applicant's mark and a space for indicating the relationship or
- 16 lack of relationship of the witness to the applicant;
- 17 (C) a space for entering an applicant's telephone
- 18 number, with a statement informing the applicant that failure to
- 19 furnish that information does not invalidate the application;
- 20 (D) a space or box for an applicant applying on
- 21 the ground of age or disability to indicate that the address to
- 22 which the ballot is to be mailed is the address of a facility or
- 23 relative described by Section 84.002(a)(3), if applicable;
- (E) a space or box for an applicant applying on
- 25 the ground of confinement in jail to indicate that the address to
- 26 which the ballot is to be mailed is the address of a relative
- 27 described by Section 84.002(a)(4), if applicable;

- 1 (F) a space for an applicant applying on the
- 2 ground of age or disability to indicate if the application is an
- 3 application under Section 86.0015;
- 4 (G) spaces for entering the signature, printed
- 5 name, and residence address of any person assisting the applicant;
- 6 (H) a statement informing the applicant of the
- 7 condition prescribed by Section 81.005; and
- 8 (I) a statement informing the applicant of the
- 9 requirement prescribed by Section 86.003(c).
- SECTION 4. Section 86.001, Election Code, is amended by
- 11 adding Subsection (f) to read as follows:
- 12 (f) If the application does not include the information
- 13 required under Section 84.002(a)(1-a), the clerk shall reject the
- 14 application.
- 15 SECTION 5. Section 86.002, Election Code, is amended by
- 16 adding Subsections (g) and (h) to read as follows:
- 17 (g) The ballot envelope must include a space for the voter
- 18 to enter the following information:
- 19 (1) the number of the voter's election identification
- 20 certificate or unexpired driver's license or personal
- 21 identification card issued by the Department of Public Safety;
- 22 (2) the voter's voter registration number;
- 23 (3) the number of the voter's unexpired United States
- 24 passport; or
- 25 (4) the voter's social security number.
- 26 (h) No record associating an individual voter with a ballot
- 27 may be created.

- 1 SECTION 6. Section 87.041(b), Election Code, is amended to
- 2 read as follows:
- 3 (b) A ballot may be accepted only if:
- 4 (1) the carrier envelope certificate is properly
- 5 executed;
- 6 (2) neither the voter's signature on the ballot
- 7 application nor the signature on the carrier envelope certificate
- 8 is determined to have been executed by a person other than the
- 9 voter, unless signed by a witness;
- 10 (3) the voter's ballot application states a legal
- 11 ground for early voting by mail;
- 12 (4) the voter is registered to vote, if registration
- 13 is required by law;
- 14 (5) the address to which the ballot was mailed to the
- 15 voter, as indicated by the application, was outside the voter's
- 16 county of residence, if the ground for early voting is absence from
- 17 the county of residence;
- 18 (6) for a voter to whom a statement of residence form
- 19 was required to be sent under Section 86.002(a), the statement of
- 20 residence is returned in the carrier envelope and indicates that
- 21 the voter satisfies the residence requirements prescribed by
- 22 Section 63.0011; [and]
- 23 (7) the address to which the ballot was mailed to the
- 24 voter is an address that is otherwise required by Sections 84.002
- 25 and 86.003; and
- 26 (8) the voter has provided the information required
- 27 under Section 86.002(g).

- SECTION 7. The changes in law made by this Act apply only to an application to vote an early voting ballot by mail submitted on or after the effective date of this Act. An application to vote an early voting ballot by mail submitted before the effective date of this Act is governed by the law in effect when the application was submitted, and the former law is continued in effect for that purpose.
- 8 SECTION 8. This Act takes effect September 1, 2021.
