14	(2) may not use a prospective tenant's choice to pay a

2	(1) evidence of damages or unpaid rent that the
3	landlord submitted to the insurer;
4	(2) evidence of damage repair costs that the landlord
5	submitted to the insurer; and
6	(3) a copy of the settled claim that documents
7	payments made by the insurer to the landlord.
8	SECTION 2. Section 92.111, Property Code, as added by this
9	Act, applies only to a lease entered into or renewed on or after the
10	effective date of this Act. A lease entered into or renewed before
11	the effective date of this Act is governed by the law as it existed
12	immediately before the effective date of this Act, and that law is
13	continued in effect for that purpose.
14	SECTION 3. This Act takes effect September 1, 2021.
