2	relating to the authorization of alternative assessment
3	instruments for use under the public school accountability system.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter B, Chapter 39, Education Code, is
6	amended by adding Section 39.040 to read as follows:
7	Sec. 39.040. ALTERNATIVE ASSESSMENT INSTRUMENTS. (a) The
8	commissioner by rule shall adopt procedures to identify nationally
9	recognized assessment instruments as additional alternative
10	assessment instruments that may be used to evaluate student
11	achievement for purposes of complying with accountability
12	requirements under this chapter.
13	(b) Additional alternative assessment instruments
14	identified as provided by Subsection (a) may be used:
15	(1) for grades three through eight, provided that the
16	commissioner obtains any necessary waiver from the application of
17	any conflicting federal law or regulation as provided by Subsection
18	(d); and
19	(2) for secondary-level courses.
20	(c) The procedures adopted to identify all additional
21	alternative assessment instruments under Subsection (a) must be

consistent with the federal procedures required by the Every

Student Succeeds Act (20 U.S.C. Section 6311) for state approval of

nationally recognized high school academic assessment instruments

- 1 that are available for local selection, including requiring each
- 2 additional alternative assessment instrument identified to be
- 3 aligned with the essential knowledge and skills for the appropriate
- 4 grade level in the subject assessed.
- 5 (d) For purposes of using additional alternative assessment
- 6 instruments in grades three through eight, the commissioner shall
- 7 seek a waiver from the application of any conflicting federal law or
- 8 regulation as a result of the use of multiple assessment
- 9 instruments for assessing students in the same grade.
- 10 SECTION 2. Not later than September 1, 2022, the
- 11 commissioner of education shall:
- 12 (1) adopt rules regarding alternative assessment
- 13 instruments as required by Section 39.040, Education Code, as added
- 14 by this Act; and
- 15 (2) request from the United States Department of
- 16 Education a waiver from the application of any conflicting federal
- 17 law or regulation as required by Section 39.040(d), Education Code,
- 18 as added by this Act, or a written notification that a waiver is not
- 19 required.
- 20 SECTION 3. This Act takes effect immediately if it receives
- 21 a vote of two-thirds of all the members elected to each house, as
- 22 provided by Section 39, Article III, Texas Constitution. If this
- 23 Act does not receive the vote necessary for immediate effect, this
- 24 Act takes effect September 1, 2021.
