BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Chapter 48, Education Code, is amended by adding Subchapter I to read as follows:

COMPENSATION AND REIMBURSEMENT. 48.404. A member of the commission is not entitled to compensation for service on the commission but is entitled to reimbursement for actual and necessary expenses incurred in performing commission duties.

Sec. 48.405. ADMINISTRATIVE SUPPORT AND FUNDING. (a) The agency shall provide administrative support for the commission.

(b) Funding for the administrative and operational expenses the commission shall be provided by legislative appropriation made to the agency for that purpose.

(a) The commission shall Sec. 48.406. RECOMMENDATIONS. develop recommendations to address issues related to the delivery of and funding for virtual education, including alternative instructional delivery methods and alternative methods of funding.

(b) The commission may establish one or more working groups composed of not more than five members of the commission to study, discuss, and address specific policy issues and recommendations to refer to the commission for consideration.

Sec. 48.407. REPORT. Not later than December 31, commission shall prepare and deliver a report to the governor and the legislature that contains commission recommendations for legislative action to improve the implementation of virtual education.

Sec. 48.409. COMMISSION ABOLISHED; EXPIRATION SUBCHAPTER. The commission is abolished and this subchapter expires

January 1, 2023.

SECTION 2. This Act applies beginning with the 2021-2022

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2021.
