25	Art. 45.306. YOUTH DIVERSION PLAN. (a) A youth diversion
26	plan is a written plan that describes the types of strategies that
27	will be used to implement youth diversion. A youth diversion plan

- 1 does not limit the types of diversion strategies that may be imposed
- 2 under a diversion agreement under Article 45.312.
- 3 (b) Each justice and municipal court shall adopt a youth
- 4 diversion plan.
- 5 (c) A youth diversion plan may be devised for a county or
- 6 municipality or an individual court within a county or
- 7 municipality.
- 8 (d) In accordance with Chapter 791, Government Code, a local
- 9 government may enter into an agreement with one or more local
- 10 governments to create a regional youth diversion plan and
- 11 collaborate in the implementation of this subchapter.
- 12 (e) A youth diversion plan may include an agreement with a
- 13 service provider to provide services for a diversion strategy.
- 14 (f) A youth diversion plan may contain guidelines for
- 15 disposition or diversion of a child's case by law enforcement under

- (h) A current youth diversion plan must be maintained on

- 27 coordinate services under a youth diversion plan or to implement

- 1 Art. 45.308. YOUTH DIVERSION ADVISORY COUNCIL. (a) A
- 2 commissioners court of a county or the governing body of a
- 3 municipality may establish a youth diversion advisory council.
- 4 (b) The purpose of a youth diversion advisory council is to
- 5 facilitate community input, suggest improvements to a youth
- 6 diversion plan, and make recommendations to accomplish the
- 7 following objectives:
- 8 (1) to provide children the option of an alternative,
- 9 non-adversarial procedure to resolve certain charges while
- 10 ensuring that the child's legal rights are protected;
- 11 (2) to authorize diversions from criminal prosecution
- 12 under this subchapter that emphasize accountability and
- 13 responsibility of the parent and the child for the child's conduct;
- 14 (3) to reduce recidivism and the occurrence of problem

- 2 of a county or the governing body of a municipality may establish a
- 3 first offense diversion program for the referral and disposition of
- 4 a case before the filing of a charge for a first offense.
- 5 (c) A county or municipality in which a program has been
- 6 established shall designate one or more peace officers, law
- 7 enforcement agencies, or service providers to process children in
- 8 the program.
- 9 (d) In lieu of issuing a citation to a child or filing a
- 10 complaint in a justice or municipal court, a peace officer who has a
- 11 child in custody may refer the child to the peace officer, law
- 12 enforcement agency, or service provider designated under
- 13 <u>Subsection</u> (c) if:
- 14 (1) the child has not previously been referred to a
- 15 program under this article; and
- 16 (2) the officer reports the referral in writing to the

- 3 (f) Before a child is referred to a program, the child and
- 4 the child's parent must consent to the referral.
- 5 (g) A referral to a program under this article may be for a
- 6 period of not more than 180 days.
- 7 (h) Diversion strategies in a program may include:
- 8 (1) voluntary restitution by the child or the child's
- 9 parent to the victim of the child's conduct;
- 10 (2) voluntary community service by the child;
- 11 (3) educational or vocational training, counseling,
- 12 or other rehabilitative services;
- 13 (4) referral of the child to a service provider or
- 14 other diversion strategy specified in a youth diversion plan; and
- 15 (5) periodic reporting by the child to the peace
- 16 officer, law enforcement agency, or service provider to which the
- 17 child is referred.
- 18 (i) The case of a child who successfully completes a program
- 19 is closed and may not be referred to court.
- 20 (j) The case of a child referred to a program shall be
- 21 referred to a prosecutor or to court, or as specified in a youth
- 22 <u>diversion plan, if:</u>
- 23 (1) the child fails to complete the program;
- 24 (2) the child or the child's parent terminates the
- 25 child's participation in the program before the child completes the
- 26 program; or
- 27 (3) the child is alleged to have committed another

- 1 offense during the child's participation in the program.
- 2 (k) A statement made by a child to a person while
- 3 participating in a program may not be used against the child in any
- 4 subsequent court proceeding.
- 5 Art. 45.312. DIVERSION AGREEMENT. (a) A diversion
- 6 agreement must identify the parties to the agreement and the
- 7 responsibilities of the child and the child's parent to ensure
- 8 their meaningful participation in a diversion under Article 45.313
- 9 or 45.314.
- 10 (b) Stated objectives in a diversion agreement must be
- 11 measurable, realistic, and reasonable considering the
- 12 circumstances of the child and the best interests of the child and
- 13 the community.
- 14 (c) A diversion agreement must include:
- 15 (1) the terms of the agreement, including any
- 16 diversion strategy, written in a clear and concise manner and
- 17 identifying any offense or charge being diverted;
- 18 (2) possible consequences of a successful diversion
- 19 and an unsuccessful diversion;
- 20 (3) an explanation that participation in a diversion
- 21 is not an admission of guilt and a guilty plea is not required to
- 22 participate in a diversion;
- 23 (4) an explanation of the process that will be used for
- 24 reviewing and monitoring compliance with the terms of the
- 25 agreement;
- 26 (5) the period of the diversion;
- 27 (6) a verification that:

- 1 (A) the child and the child's parent were
- 2 notified of the child's rights, including the right to refuse
- 3 diversion; and
- 4 (B) the child knowingly and voluntarily consents
- 5 to participate in the diversion; and
- 6 (7) written acknowledgment and acceptance of the
- 7 agreement by the child and the child's parent.
- 8 <u>(d) The terms of an agreement may vary depending on the</u>
- 9 circumstances of the child, including the child's age and ability,
- 10 the charge being diverted, the diversion program, or the diversion
- 11 strategy.
- 12 (e) A charge may not be filed against a child or, if filed,
- 13 shall be dismissed if the child:
- 14 (1) does not contest the charge;
- 15 (2) is eligible for diversion under Article 45.304;
- 16 and
- 17 (3) accepts the terms of the agreement.
- 18 (f) Entering into a diversion agreement under this article
- 19 extends the court's jurisdiction for the term of the agreement.
- 20 (g) On entering into a diversion agreement, a copy of the
- 21 agreement shall be provided to the child and the child's parent, the
- 22 clerk of the court, a youth diversion coordinator, and any person
- 23 specified by the youth diversion plan.
- 24 Art. 45.313. INTERMEDIATE DIVERSION FROM COURT. (a) If
- 25 provided by a youth diversion plan and subject to the direction of
- 26 the court, a youth diversion coordinator, juvenile case manager, or

- 2 (c) After the hearing, a court may enter an order:

- 8 not to exceed 60 days to allow an opportunity for compliance with

- (e) An order under Subsection (c)(4) is enforceable by
- 24 contempt.
- 25 Art. 45.316. LOCAL YOUTH DIVERSION ADMINISTRATIVE FEE.
- 26 (a) The clerk of a justice or municipal court may collect from a
- 27 child's parent a \$30 administrative fee to defray the costs of the

- 1 <u>diversion of the child's case under this subchapter.</u>
- 2 (b) The fee under this article may not be collected unless
- 3 specified as a term of the diversion agreement accepted by the
- 4 child's parent. If the fee is not paid after giving the child's
- 5 parent an opportunity to be heard, the court shall order the parent,
- 6 if financially able, to pay the fee to the clerk of the court.
- 7 (c) A court shall waive the fee if the child's parent is
- 8 indigent or does not have sufficient resources or income to pay the
- 9 fee.
- 10 (d) A court may adopt rules for the waiver of a fee for
- 11 financial hardship under this article.
- 12 (e) The clerk of the court shall keep a record of the fees
- 13 collected under this article and shall forward the funds to the
- 14 county treasurer, municipal treasurer, or person fulfilling the

- in a special account that can be used only to offset the cost of the

- 21 (h) The diversion of a child may not be contingent on
