1-20 relating to the state historic sites and parks under the
 1-21 jurisdiction of the Texas Historical Commission.

1-22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-23 SECTION 1. Section 442.072(a), Government Code, is amended
 1-24 to read as follows:

1-25 (a) The following historic sites and parks are under the
 1-26 commission's jurisdiction:

2-2 SECTION 2. The heading to Section 442.076, Government Code,
2-3 is amended to read as follows:

2-4 Sec. 442.076. FRENCH LEGATION STATE HISTORIC SITE.

2-5 SECTION 3. Sections 442.076(a) and (b), Government Code,
2-6 are amended to read as follows:

2-7 (a) The commission is responsible for:

2-8 (1) the preservation, maintenance, and restoration of
2-9 the [~~property known as the~~] French Legation State Historic Site
2-10 [~~and its contents~~]; and

2-11 (2) the protection of the historical and architectural
2-12 integrity of the building exterior, building interior, and grounds
2-13 of the French Legation State Historic Site.

2-14 (b) Any power or duty related to the French Legation State
2-15 Historic Site formerly vested in another state agency or entity is
2-16 vested solely in the commission.

2-17 SECTION 4. Section 442.077, Government Code, is amended to
2-18 read as follows:

2-19 Sec. 442.077. AGREEMENT RELATING TO FRENCH LEGATION STATE
2-20 HISTORIC SITE. The commission may enter into an agreement with the
2-21 Daughters of the Republic of Texas regarding the management,
2-22 staffing, parking facilities, operation, and financial support of
2-23 the [~~property known as the~~] French Legation State Historic Site.

2-24 SECTION 5. The heading to Subchapter G, Chapter 442,
2-25 Government Code, is amended to read as follows:

2-26 SUBCHAPTER G. PORT ISABEL LIGHTHOUSE STATE HISTORIC SITE
2-27 [~~HISTORICAL MONUMENT AND PARK~~]

2-28 SECTION 6. Section 442.271, Government Code, is amended to
2-29 read as follows:

2-30 Sec. 442.271. JURISDICTION. (a) The Port Isabel
2-31 Lighthouse State Historic Site is a state historical monument and
2-32 park and is under the jurisdiction of the commission.

2-33 (b) The Port Isabel Lighthouse State Historic Site
2-34 [~~Historical Monument and Park~~] is a historic site for purposes of
2-35 Subchapter C.

2-36 SECTION 7. This Act takes effect September 1, 2021.
