H.B. No. 3737

A BILL TO BE ENTITLED

AN ACT

relating to the composition of districts for the election of members of the State Board of Education.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

ARTICLE I

SECTION 1. (a) The members of the State Board of Education are elected from the districts described by Article II of this Act.

(b) One member is elected from each district established by this Act.

(c) For purposes of Section 7.104, Education Code, this Act constitutes a decennial reapportionment.

24 ARTICLE III

25 SECTION 1. In this Act, "tract," "block group," and "block"
26 mean the geographic areas identified by those terms on the 2010
27 Census TIGER/Line Shapefiles, prepared by the federal Bureau of the

1 Census for the Twenty-third Decennial Census of the United States,
2 enumerated as of April 1, 2010.

3 SECTION 2. It is the intent of the legislature that if any
4 county, tract, block group, block, or other geographic area has
5 erroneously been left out of this Act, a court reviewing this Act
6 should include that area in the appropriate district in accordance
7 with the intent of the legislature, using any available evidence of
8 that intent, including evidence such as that used by the Supreme
9 Court of Texas in Smith v. Patterson, 111 Tex. 535, 242 S.W. 749
10 (1922).

11 SECTION 3. (a) This Act supersedes all previous enactments
12 or orders adopting districts for the State Board of Education. All
13 previous acts of the legislature adopting districts for the State
14 Board of Education are repealed.

15 (b) Chapter 72 (H.B. 600), Acts of the 82nd Legislature,
16 Regular Session, 2011, is repealed.

17 SECTION 4. The districts set out in Article II of this Act
18 apply to the election of the members of the State Board of Education
19 beginning with the primary and general elections in 2022 for
20 members of the board in 2023. This Act does not affect the
21 membership or districts of the board before January 1, 2023.

22 SECTION 5. This Act takes effect immediately if it receives
23 a vote of two-thirds of all the members elected to each house, as
24 provided by Section 39, Article III, Texas Constitution. If this
25 Act does not receive the vote necessary for immediate effect, this
26 Act takes effect September 1, 2021.
