program, as defined by the coordinating board, offered by an

- 20 (2) align career education and training programs to

- Sec. 2308A.003. INTERAGENCY AGREEMENTS AND STAFFING. (a)
- 27 The agency, coordinating board, and commission shall enter into one

- 3 (1) sharing and matching relevant data and
- 4 cooperatively managing education and workforce information
- 5 collected by each respective agency; and
- 6 (2) coordinating the assignment of existing staff and

- 9 developed under Section 2308A.006.
- 10 (b) The time spent by an employee of the agency,
- 11 coordinating board, or commission in supporting the work of the
- 12 initiative is not included in calculating the number of full-time

- Sec. 2308A.004. QUARTERLY DISCUSSIONS. The commissioner of

- 17 commission shall discuss the work of the initiative at least once

- 19 Sec. 2308A.005. STRATEGIC PLAN FOR UNIFIED WORKFORCE DATA
- 20 REPOSITORY. (a) The coordinating board shall develop a strategic
- 21 plan for the operation of a unified repository for education and
- 22 workforce data. In developing the plan, the coordinating board
- 23 shall solicit input from the agency, the commission, and relevant
- 24 stakeholders.
- 25 (b) The plan developed under Subsection (a) must include
- 26 recommendations for:
- 27 (1) automatically matching records of the agency,

- 17 Sec. 2308A.006. STATE WORKFORCE DEVELOPMENT GOALS AND
- 18 STRATEGIES. (a) The commissioner of education, commissioner of
- 19 higher education, and chair of the commission jointly shall develop
- 20 and post in a prominent location on the initiative's and each
- 21 respective agency's Internet website state workforce development
- 22 goals and coordinated interagency strategies for achieving those
- 23 goals.
- 24 (b) The goals developed under Subsection (a) must:
- 25 (1) be developed in consultation with employers;
- 26 (2) include goals for the attainment of employment in
- 27 jobs that pay a self-sufficient wage for all career education and

2	(3) be disaggregated by race, ethnicity, and gender

- 18 the initiative's and each respective agency's Internet website the
- 19 proposed goals or strategies and instructions for submitting
- 20 comment on those items to the agencies.
- 21 Sec. 2308A.011. TARGETED FUNDING TO ADDRESS STATE GOALS.
- 22 (a) A state agency that receives funding through the Carl D. Perkins
- 23 Career and Technical Education Act of 2006 (20 U.S.C. Section 2301
- 24 et seq.) or the Workforce Innovation and Opportunity Act (Pub. L.
- 25 No. 113-128) or any other federal funding for career education and
- 26 training may, to the extent permissible under federal law, combine
- 27 with, transfer to, or delegate to another state agency that

- 1 receives such funding the agency's management of workforce-related
- 2 funding as necessary to implement the state workforce development

- 4 (b) A state agency that receives federal or state funding

- 13 common standard that reflects the regionally adjusted minimum
- 14 employment earnings necessary to meet a family's basic needs while

- Sec. 2308A.013. GIFTS, GRANTS, AND DONATIONS. (a) The
- 17 agency, coordinating board, and commission may accept gifts,
