An occupational policy shall include the following disclosure statement in 10-point boldface type on the first page of 18 the policy and on the first page of all materials used in 19 advertising or marketing the occupational policy to an employer 20 that elects not to maintain workers' compensation insurance 21 coverage under Chapter 406, Labor Code: 22 "THIS IS NOT A WORKERS' COMPENSATION INSURANCE POLICY. THE 23 24 EMPLOYER DOES NOT OBTAIN WORKERS' COMPENSATION INSURANCE COVERAGE BY PURCHASING THIS POLICY, AND IF THE EMPLOYER HAS NOT ELECTED TO 25 26 OBTAIN WORKERS' COMPENSATION INSURANCE COVERAGE, THE EMPLOYER DOES NOT OBTAIN THOSE BENEFITS THAT WOULD OTHERWISE ACCRUE UNDER THE 27

- 6 Sec. 564.006. RULES. The commissioner shall adopt rules as
- 7 necessary to implement this chapter.
- 8 SECTION 2. As soon as practicable after the effective date
- 9 of this Act, the commissioner of insurance shall adopt rules to
- 10 implement Chapter 564, Insurance Code, as added by this Act.
- 11 SECTION 3. Chapter 564, Insurance Code, as added by this
- 12 Act, applies only to an occupational insurance policy delivered,
- 13 issued for delivery, or renewed on or after January 1, 2022. An
- 14 occupational insurance policy delivered, issued for delivery, or
- 15 renewed before January 1, 2022, is governed by the law as it existed
- 16 immediately before the effective date of this Act, and that law is
- 17 continued in effect for that purpose.
- 18 SECTION 4. This Act takes effect September 1, 2021.
