horticultural or agricultural products or livestock. The term does 1 not include: 2 3 (A) an association that holds a license issued after January 1, 2001, under Subtitle A-1, Title 13, Occupations 4 5 Code (Texas Racing Act); or 6 (B) an association that organizes events other than a county fair, including an exhibition of arts and crafts or a 7 8 state fair. 9 (2) "Livestock" includes turkeys, domesticated fowl, cows, sheep, swine, horses, mules, donkeys, and goats. The term 10 does not include domesticated animals such as dogs, cats, guinea 11 12 pigs, hamsters, or other similar animals. SECTION 2. The change in law made by this Act does not 13 affect tax liability accruing before the effective date of this 14 15 Act. That liability continues in effect as if this Act had not been enacted, and the former law is continued in effect for the 16 collection of taxes due and for civil and criminal enforcement of 17

18 the liability for those taxes.
