- 5 Sec. 13.023. LIFEGUARDS AND SIGNAGE IN CERTAIN AREAS. (a)
- 6 The department shall:
- 7 (1) during reasonable daylight hours, as established
- 8 and posted by the department, from Memorial Day to Labor Day,
- 9 provide:
- 10 (A) occupied lifeguard towers or mobile
- 11 lifeguard units on each side of each pier, jetty, or other structure
- 12 that protrudes into the Gulf of Mexico that is located within a
- 13 state park; or
- 14 (B) a single occupied lifeguard tower or mobile
- 15 lifeguard unit at each pier, jetty, or other structure that
- 16 protrudes into the Gulf of Mexico that is located within a state
- 17 park if the single tower provides an unobstructed view of both sides
- 18 of each structure; and
- 19 (2) post within 100 yards of each side of each
- 20 structure described by Subdivision (1) signs clearly describing the

- (b) The department may suspend or alter the duties imposed

- 25 SECTION 6. The Parks and Wildlife Department is required to

- 2 purpose, that agency may, but is not required to, implement a
- 3 provision of this Act using other appropriations available for that
- 4 purpose.
- 5 SECTION 7. This Act takes effect September 1, 2021.
