## A BILL TO BE ENTITLED

- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4
- SECTION 1. Subchapter C, Chapter 7932, Special District 5
- Local Laws Code, is amended by adding Section 7932.106 to read as 6
- follows: 7

- Sec. 7932.106. DIVISION OF DISTRICT. (a) The district may 8
- 9 be divided into two or more new districts only if the district:
- (1) has no outstanding bonded debt; and 10
- 11 (2) is not imposing ad valorem taxes.
- 12 (b) This chapter applies to any new district created by the
- division of the district, and a new district has all the powers and 13
- 14 duties of the district.
- (c) A new district created by the division of the district 15
- 16 may not, at the time the new district is created, contain any land
- outside the area located within the district as of January 1, 2021. 17
- (d) The board, on its own motion or on receipt of a petition 18
- 19 signed by the owner or owners of a majority of the assessed value of
- the real property in the district, may adopt an order dividing the 20
- district. 21
- (e) The board may adopt an order dividing the district 22
- 23 before or after the date the board holds an election under Section
- 7932.003 to confirm the district's creation. 24

- 1 (f) An order dividing the district shall:
- 2 (1) name each new district;
- 3 (2) include the metes and bounds description of the
- 4 territory of each new district;
- 5 (3) appoint temporary directors for each new district;
- 6 <u>and</u>
- 7 (4) provide for the division of assets and liabilities
- 8 between the new districts.
- 9 (g) On or before the 30th day after the date of adoption of
- 10 an order dividing the district, the district shall file the order
- 11 with the commission and record the order in the real property
- 12 records of each county in which the district is located.
- 13 (h) Any new district created by the division of the district
- 14 shall hold a confirmation and directors' election as required by
- 15 <u>Section 7932.003.</u>
- (i) If the creation of the new district is confirmed, the
- 17 new district shall provide the election date and results to the
- 18 commission.
- 19 (j) Any new district created by the division of the district
- 20 must hold an election as required by this chapter to obtain voter
- 21 approval before the district may impose a maintenance tax or issue
- 22 bonds payable wholly or partly from ad valorem taxes.
- 23 (k) Municipal consent to the creation of the district and to
- 24 the inclusion of land in the district acts as municipal consent to
- 25 the creation of any new district created by the division of the
- 26 district and to the inclusion of land in the new district.
- 27 SECTION 2. This Act takes effect immediately if it receives

- 1 a vote of two-thirds of all the members elected to each house, as
- 2 provided by Section 39, Article III, Texas Constitution. If this
- 3 Act does not receive the vote necessary for immediate effect, this
- 4 Act takes effect September 1, 2021.
