6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Chapter 140, Local Government Code, is amended
8	by adding Section 140.0047 to read as follows:
9	Sec. 140.0047. ELECTION REQUIRED FOR REDUCTION IN BUDGET
10	FOR PUBLIC SAFETY PERSONNEL EXPENSES. (a) In this section:
11	(1) "Public safety personnel expenses" means money
12	spent to train and compensate individuals who provide a public
13	safety service.
14	(2) "Public safety service" means a fire protection,
15	law enforcement, or emergency medical service.
16	(b) This section does not apply to the budget for a
17	municipal department that employs 20 or fewer public safety
18	personnel for a public safety service.
19	(c) If a county or municipality adopts a budget in which the
20	amount of money allocated for public safety personnel expenses for
21	a public safety service is less than the amount allocated for those
22	expenses in the preceding fiscal year by more than the sum of the
23	percentage by which the county's or municipality's total revenue is
24	reduced from the preceding fiscal year and five percent, the

1 registered voters of the county or municipality, as applicable, at
2 an election held for that purpose, must determine whether to
3 approve the amount allocated.
4 (d) The governing body of the county or municipality shall
5 order that the election be held in the county or municipality, as
6 applicable, on the earliest date that allows sufficient time to
7 comply with the requirements of other law for holding the election,

8 except Section 41.001(a), Election Code. Notwithstanding Section
9 <u>41.001(a)</u>, Election Code, the county or municipality may hold the
10 <u>election on a date other than a uniform election date.</u>

(e) If a majority of votes cast in the election favor 11 12 approving the amount allocated for the public safety personnel expenses, the budget is approved. If the amount allocated is not 13 14 approved, the governing body shall amend the budget by allocating 15 for the public safety personnel expenses an amount for the current fiscal year that is not less than the amount allocated for those 16 17 expenses in the preceding fiscal year reduced by a percentage equal to the sum of the percentage by which the county's or municipality's 18 19 total revenue is reduced from the preceding fiscal year and five 20 percent.

21 (f) For purposes of determining the amount of reduction of 22 the amount allocated in a budget for public safety personnel 23 expenses, reductions of the budget related to the termination of 24 personnel for bad conduct are not included.

25 SECTION 2. The change in law made by this Act applies only 26 to a budget adopted by a county or municipality on or after the 27 effective date of this Act.

1 SECTION 3. This Act takes effect immediately if it receives 2 a vote of two-thirds of all the members elected to each house, as 3 provided by Section 39, Article III, Texas Constitution. If this 4 Act does not receive the vote necessary for immediate effect, this 5 Act takes effect September 1, 2021.
