A BILL TO BE ENTITLED 1 AN ACT 2 relating to repealing the prohibition on promoting homosexuality in 3 certain educational materials and instruction. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 SECTION 1. Section 85.007(b), Health and Safety Code, is 5 amended to read as follows: 6 7 (b) The materials in the education programs intended for persons younger than 18 years of age must [+ 8 [(1)] emphasize sexual abstinence before marriage and 9 fidelity in marriage as the expected standard in terms of public 10 11 health and the most effective ways to prevent HIV infection, 12 sexually transmitted diseases, and unwanted pregnancies[; and 13 [(2) state that homosexual conduct is not an acceptable 14 lifestyle and is a criminal offense under Section 21.06, Code]. 15 SECTION 2. Section 163.002, Health and Safety Code, is 16 amended to read as follows: 17 Sec. 163.002. INSTRUCTIONAL ELEMENTS. Course materials and 18 instruction relating to sexual education or sexually transmitted 19 diseases should include: 20 21 (1)an emphasis on sexual abstinence as the only 22 completely reliable method of avoiding unwanted teenage pregnancy 23 and sexually transmitted diseases; (2) an emphasis on the importance of self-control, 24

1 responsibility, and ethical conduct in making decisions relating to
2 sexual behavior;

3 (3) statistics, based on the latest medical 4 information, that indicate the efficacy of the various forms of 5 contraception;

6 (4) information concerning the laws relating to the 7 financial responsibilities associated with pregnancy, childbirth, 8 and child rearing;

9 (5) information concerning the laws prohibiting 10 sexual abuse and the legal and counseling options available to 11 victims of sexual abuse;

12 (6) information on how to cope with and rebuff 13 unwanted physical and verbal sexual advances, as well as the 14 importance of avoiding the sexual exploitation of other persons; 15 <u>and</u>

16 (7) psychologically sound methods of resisting 17 unwanted peer pressure[; and

18 [(8) emphasis, provided in a factual manner and from a 19 public health perspective, that homosexuality is not a lifestyle 20 acceptable to the general public and that homosexual conduct is a 21 criminal offense under Section 21.06, Penal Code].

22 SECTION 3. This Act takes effect immediately if it receives 23 a vote of two-thirds of all the members elected to each house, as 24 provided by Section 39, Article III, Texas Constitution. If this 25 Act does not receive the vote necessary for immediate effect, this 26 Act takes effect September 1, 2021.
