- 8 under the foundation school program.
- 9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 10 SECTION 1. Subchapter C, Chapter 7, Education Code, is
- 11 amended by adding Section 7.071 to read as follows:
- 12 Sec. 7.071. INSTRUCTION-RELATED PURCHASE BY COMMISSIONER.
- 13 (a) Using funds appropriated for the purpose or otherwise
- 14 available to the commissioner in the form of grants, the
- 15 commissioner may purchase curriculum programs, instructional
- 16 materials, and other instructional tools to provide for use by
- 17 school districts and open-enrollment charter schools.
- 18 (b) To leverage state purchasing power and ensure
- 19 cost-effective use of taxpayer funds, the commissioner may contract
- 20 <u>on behalf of a school district or open-enrollment charter school to</u>
- 21 purchase any item for instructional purposes, provided that the
- 22 district or school dedicates local funds for the purpose.
- SECTION 2. The heading to Section 28.0211, Education Code,
- 24 is amended to read as follows:

- 1 Sec. 28.0211. <u>ACCELERATED LEARNING COMMITTEE</u> [SATISFACTORY
- 2 PERFORMANCE ON ASSESSMENT INSTRUMENTS REQUIRED]; ACCELERATED

- 4 SECTION 3. Section 28.0211, Education Code, is amended by

- 6 and (n) and adding Subsections (a-4), (a-5), (a-6), (f-1), (f-2),
- 7 (f-3), (f-4), (f-5), and (n-1) to read as follows:
- 8 (a) A school district shall establish an accelerated
- 9 learning committee described by Subsection (c) for each student who
- 10 does not perform satisfactorily on:
- 11 (1) the third grade mathematics or reading assessment
- 12 <u>instrument under Section 39.023;</u>
- 13 (2) [Except as provided by Subsection (b) or (e), a
- 14 student may not be promoted to:
- 15 [(1) the sixth grade program to which the student
- 16 would otherwise be assigned if the student does not perform
- 17 satisfactorily on] the fifth grade mathematics or [and] reading
- 18 assessment instrument [instruments] under Section 39.023; or
- 19 (3) [(2) the ninth grade program to which the student
- 20 would otherwise be assigned if the student does not perform
- 21 satisfactorily on] the eighth grade mathematics or [and] reading
- 22 assessment instrument [instruments] under Section 39.023.
- 23 (a-1) Each time a student fails to perform satisfactorily on
- 24 an assessment instrument administered under Section 39.023(a) in
- 25 the third, fourth, fifth, sixth, seventh, or eighth grade, the
- 26 school district in which the student attends school shall provide
- 27 to the student accelerated instruction in the applicable subject

- 1 area during the subsequent summer or school year and either:
- 2 (1) allow the student to be assigned a classroom
- 3 teacher who is certified as a master, exemplary, or recognized
- 4 teacher under Section 21.3521 for the subsequent school year in the
- 5 applicable subject area; or
- 6 (2) provide the student supplemental instruction
- 7 under Subsection (a-4).
- 8 (a-2) Accelerated instruction provided during the following
- 9 school year under Subsection (a-1) may require participation of the
- 10 student before or after normal school hours [and may include
- 11 participation at times of the year outside normal school
- 12 operations].
- 13 (a-3) In providing accelerated instruction under Subsection
- 14 (a-1), a district may not remove a student, except under
- 15 circumstances for which a student enrolled in the same grade level
- 16 who is not receiving accelerated instruction would be removed,
- 17 from:
- 18 <u>(1) instruction in the foundation curriculum and</u>
- 19 enrichment curriculum adopted under Section 28.002 for the grade
- 20 level in which the student is enrolled; or
- 21 (2) recess or other physical activity that is
- 22 available to other students enrolled in the same grade level.
- 23 <u>(a-4) Supplemental instruction provided by a school</u>
- 24 district under Subsection (a-1)(2) must:
- 25 (1) include targeted instruction in the essential
- 26 knowledge and skills for the applicable grade levels and subject
- 27 area;

- 1 (2) be provided in addition to instruction normally
- 2 provided to students in the grade level in which the student is
- 3 enrolled;
- 4 (3) be provided for no less than 30 total hours during
- 5 the subsequent summer or school year and, unless the instruction is
- 6 provided fully during summer, include instruction no less than once
- 7 per week during the school year;
- 8 <u>(4) be designed to assist the student in achieving</u>
- 9 satisfactory performance in the applicable grade level and subject
- 10 <u>area;</u>
- 11 (5) include effective instructional materials
- 12 designed for supplemental instruction;
- 13 (6) be provided to a student individually or in a group
- 14 of no more than three students, unless the parent or guardian of
- 15 <u>each student in the group authorizes a larger group;</u>
- 16 (7) be provided by a person with training in the
- 17 applicable instructional materials for the supplemental
- 18 instruction and under the oversight of the school district; and
- 19 (8) to the extent possible, be provided by one person
- 20 for the entirety of the student's supplemental instruction period.
- 21 <u>(a-5)</u> If there is more than one classroom teacher available
- 22 <u>in the applicable subject area to which a student who fails to</u>
- 23 perform satisfactorily on an assessment instrument specified under
- 24 Subsection (a) could be assigned for the subsequent school year,
- 25 the student's parent or guardian may choose the teacher who will
- 26 provide the applicable instruction to the student.
- 27 [(a-2) A student who fails to perform satisfactorily on an

- 1 assessment instrument specified under Subsection (a) and who is
- 2 promoted to the next grade level must complete accelerated
- 3 instruction required under Subsection (a-1) before placement in the
- 4 next grade level. A student who fails to complete required
- 5 accelerated instruction may not be promoted.
- 6 (a-6) [(a-3)] The commissioner shall provide guidelines to
 7 school districts on research-based best practices and effective
 8 strategies that a district may use in developing an accelerated
 9 instruction program and may provide resources to districts to
 10 assist in the provision of an accelerated instruction program.
- [Each time a student fails to perform satisfactorily on 11 (c) 12 an assessment instrument specified under Subsection (a), the school district in which the student attends school shall provide to the 13 student accelerated instruction in the applicable subject area, 14 15 including reading instruction for a student who fails to perform satisfactorily on a reading assessment instrument. 16 17 student fails to perform satisfactorily on an assessment instrument specified under Subsection (a), an accelerated learning [a second 18 time, a grade placement] committee shall be established [to 19 20 prescribe the accelerated instruction the district shall provide to the student before the student is administered the assessment 21 instrument the third time]. The accelerated learning [grade 22 placement] committee shall be composed of the principal or the 23 principal's designee, the student's parent or guardian, and the 24 teacher of the subject of an assessment instrument on which the 25 26 student failed to perform satisfactorily. The district shall notify the parent or guardian of the time and place for convening 27

- 1 the <u>accelerated learning</u> [grade placement] committee and the
- 2 purpose of the committee. [An accelerated instruction group
- 3 administered by a school district under this section may not have a
- 4 ratio of more than 10 students for each teacher.
- (f) An accelerated learning [A school district shall provide to a student who, after three attempts, has failed to perform satisfactorily on an assessment instrument specified under Subsection (a) accelerated instruction during the next school year as prescribed by an educational plan developed for the student by the student's grade placement] committee described by [established under] Subsection (c) shall, not later than the start of the
- 12 <u>subsequent school year, develop an</u>[. The district shall provide
- 13 that accelerated instruction regardless of whether the student has
- 14 been promoted or retained. The] educational plan for the student
- 15 that provides the necessary accelerated instruction [must be
- 16 designed] to enable the student to perform at the appropriate grade
- 17 level by the conclusion of the school year.
- 18 (f-1) The educational plan under Subsection (f) must be
- 19 documented in writing, and a copy must be provided to the student's
- 20 parent or guardian.
- 21 (f-2) During the school year, the student shall be monitored
- 22 to ensure that the student is progressing in accordance with the
- 23 plan <u>developed under Subsection (f)</u>. The district shall administer
- 24 to the student the assessment instrument for the grade level in
- 25 which the student is placed at the time the district regularly
- 26 administers the assessment instruments for that school year.
- 27 (f-3) The board of trustees of each school district shall

- 1 adopt a policy consistent with the grievance procedure adopted
- 2 under Section 26.011 to allow a parent to contest the content or
- 3 implementation of an educational plan developed under Subsection
- 4 (f).
- 5 (f-4) If a student who fails to perform satisfactorily on an
- 6 assessment instrument specified under Subsection (a) fails in the
- 7 subsequent school year to perform satisfactorily on an assessment
- 8 instrument in the same subject, the superintendent of the district,
- 9 or the superintendent's designee, shall meet with the student's
- 10 <u>accelerated learning committee to:</u>
- 11 (1) identify the reason the student did not perform
- 12 satisfactorily; and
- 13 (2) determine, in order to ensure the student performs
- 14 <u>satisfactorily</u> on the assessment instrument at the next
- 15 administration of the assessment instrument, whether:
- 16 (A) the educational plan developed for the
- 17 student under Subsection (f) must be modified to provide the

- 2 SECTION 4. Section 28.0217, Education Code, is amended to
- 3 read as follows:
- 4 Sec. 28.0217. ACCELERATED INSTRUCTION FOR HIGH SCHOOL
- 5 STUDENTS. (a) Each time a student fails to perform satisfactorily
- 6 on an assessment instrument administered under Section 39.023(c),
- 7 the school district in which the student attends school shall
- 8 provide to the student accelerated instruction in the applicable
- 9 subject area[, using funds appropriated for accelerated
- 10 instruction under Section 28.0211].
- 11 <u>(b)</u> Accelerated instruction provided under this section:
- 12 (1) may require participation of the student before or
- 13 after normal school hours and may include participation at times of
- 14 the year outside normal school operations; and
- 15 (2) must comply with the requirements for accelerated
- 16 instruction provided under Section 28.0211.
- 17 SECTION 5. Subchapter C, Chapter 29, Education Code, is
- 18 amended by adding Section 29.0881 to read as follows:
- 19 Sec. 29.0881. STRONG FOUNDATIONS GRANT PROGRAM. (a) The
- 20 commissioner shall establish and administer a strong foundations
- 21 grant program for campuses or a program at a campus serving students
- 22 enrolled in prekindergarten through grade five to implement a
- 23 rigorous school approach that combines high-quality instruction,
- 24 materials, and support structures.
- 25 (b) The commissioner shall adopt components that school
- 26 districts, open-enrollment charter schools, and campuses of the
- 27 districts or schools must implement under the strong foundations

- 1 grant program. The components must include:
- 2 (1) use of high-quality instructional materials,
- 3 curricula, and curricular tools;
- 4 (2) use of aligned diagnostic and formative

- 9 (5) evidence-based practices to increase and maintain

- 15 (d) The commissioner shall use funds appropriated, federal

- 18 schools in implementing the program.
- 19 (e) A school district or open-enrollment charter school
- 20 that receives grant funds under this section may use the funds to:
- 21 (1) financially support or train or otherwise prepare
- 22 educators and other staff; or
- 23 (2) pay for agreements with other entities to provide

- 10 (1) includes students at any grade level from
- 11 prekindergarten through fifth grade;
- 12 (2) is assigned an overall performance rating of D or

- 14 (3) is in the bottom five percent of campuses in the

- 5 SECTION 11. Section 51.338(d), Education Code, is amended
- 6 to read as follows:
- 7 (d) A student who has demonstrated the performance standard
- 8 for college readiness as provided by Section 28.008 on the
- 9 postsecondary readiness assessment instruments adopted under
- 10 Section 39.0238 for Algebra II and English III, as that section
