- 10 623.212, [or] 623.321, or 623.451 [as added by Chapter 1135 (H.B.
- 11 2741), Acts of the 83rd Legislature, Regular Session, 2013, [ may
- 12 operate under the conditions authorized by the permit over a road
- 13 for which the executive director of the Texas Department of
- 14 Transportation has set a maximum weight under this section.
- SECTION 2. Section 621.301(e), Transportation Code, is

- 4 Sec. 623.451. PERMIT TO DELIVER AGRICULTURAL COMMODITIES.
- 5 (a) In this section:
- 6 (1) "Agricultural commodity" means an agricultural,
- 7 horticultural, viticultural, silvicultural, or vegetable product,
- 8 bees or honey, planting seed, cottonseed, rice, livestock or a
- 9 livestock product, or poultry or a poultry product that is produced
- 10 in this state, either in its natural form or as processed by the
- 11 producer, including woodchips.
- 12 (2) "Division" means the Texas Division of Emergency
- 13 Management.
- 14 (b) Notwithstanding any other law, the department may issue
- 15 <u>a special permit to an oversize or overweight vehicle or load that:</u>
- 16 (1) can easily be dismantled or divided; and
- 17 (2) will be used only to deliver agricultural
- 18 commodities.
- 19 (c) The department may issue a permit under this section
- 20 only:
- 21 (1) during an emergency or major disaster as declared
- 22 by the president of the United States under the Robert T. Stafford
- 23 Disaster Relief and Emergency Assistance Act (42 U.S.C. Section

- 8 in the manner prescribed by the department and include in the notice

- 11 (1) Subsection (c)(1) expires not later than the 120th
- 12 day after the date of the disaster or emergency declaration; or

- 15 under Subsection (d) authorizing the issuance of the permit.

- 3 (b) If the United States authorizes the operation on the
- 4 national system of interstate and defense highways or the federal
- 5 <u>aid primary highway system of a vehicle with a size or weight</u>
- 6 greater than those permitted under 23 U.S.C. Section 127 or 49
- 7 U.S.C. Sections 31111 through 31114 on September 1, 2021, the new
- 8 limit automatically takes effect on the national system of
- 9 interstate and defense highways or the federal aid primary highway
- 10 system in this state.
- 11 SECTION 4. This Act takes effect September 1, 2021.
