11	SUBCHAPTER A. GENERAL PROVISIONS		
12	Sec. 7904A.0101. DEFINITIONS. In this chapter:		
13	(1) "Board" means the district's board of directors.		
14	(2) "City" means the City of Fulshear, Texas.		
15	(3) "Commission" means the Texas Commission on		
16	Environmental Quality.		
17	(4) "Director" means a board member.		
18	(5) "District" means the Fort Bend County Municipal		
19	Utility District No. 249.		
20	Sec. 7904A.0102. NATURE OF DISTRICT. The district is a		
21	municipal utility district created under Section 59, Article XVI,		
22	Texas Constitution.		
23	Sec. 7904A.0103. CONFIRMATION AND DIRECTOR ELECTION		
24	REQUIRED. The temporary directors shall hold an election to		

- 1 confirm the creation of the district and to elect five permanent
- 2 directors as provided by Section 49.102, Water Code.
- 3 Sec. 7904A.0104. CONSENT OF MUNICIPALITY REQUIRED. The
- 4 temporary directors may not hold an election under Section
- 5 7904A.0103 until each municipality in whose corporate limits or
- 6 extraterritorial jurisdiction the district is located has
- 7 consented by ordinance or resolution to the creation of the
- 8 district and to the inclusion of land in the district.
- 9 Sec. 7904A.0105. FINDINGS OF PUBLIC PURPOSE AND BENEFIT.
- 10 (a) The district is created to serve a public purpose and benefit.
- 11 (b) The district is created to accomplish the purposes of:
- 12 (1) a municipal utility district as provided by
- 13 general law and Section 59, Article XVI, Texas Constitution; and
- 14 (2) Section 52, Article III, Texas Constitution, that
- 15 relate to the construction, acquisition, improvement, operation,
- 16 or maintenance of macadamized, graveled, or paved roads, or
- 17 improvements, including storm drainage, in aid of those roads.
- 18 Sec. 7904A.0106. INITIAL DISTRICT TERRITORY. (a) The
- 19 district is initially composed of the territory described by
- 20 Section 2 of the Act enacting this chapter.
- 21 (b) The boundaries and field notes contained in Section 2 of
- 22 the Act enacting this chapter form a closure. A mistake made in the
- 23 <u>field notes or in copying the field notes in the legislative process</u>
- 24 does not affect the district's:
- 25 <u>(1) organization, existence, or validity;</u>
- 26 (2) right to issue any type of bond for the purposes
- 27 for which the district is created or to pay the principal of and

- 1 interest on a bond; 2 (3) right to impose a tax; or 3 (4) legality or operation. SUBCHAPTER B. BOARD OF DIRECTORS 4 5 Sec. 7904A.0201. GOVERNING BODY; TERMS. (a) The district is governed by a board of five elected directors. 6 7 (b) Except as provided by Section 7904A.0202, directors 8 serve staggered four-year terms. Sec. 7904A.0202. TEMPORARY DIRECTORS. (a) On or after the 9 effective date of the Act enacting this chapter, the owner or owners 10 of a majority of the assessed value of the real property in the 11 12 district may submit a petition to the commission requesting that the commission appoint as temporary directors the five persons 13 named in the petition. The commission shall appoint as temporary 14 15 directors the five persons named in the petition. (b) Temporary directors serve until the earlier of: 16 17 (1) the date permanent directors are elected under Section 7904A.0103; or 18 19 (2) the fourth anniversary of the effective date of
- 21 (c) If permanent directors have not been elected under
- Section 7904A.0103 and the terms of the temporary directors have 22
- expired, successor temporary directors shall be appointed or 23
- 24 reappointed as provided by Subsection (d) to serve terms that
- expire on the earlier of: 25

- 3 (d) If Subsection (c) applies, the owner or owners of a

- 7 persons named in the petition. The commission shall appoint as
- 8 successor temporary directors the five persons named in the
- 9 petition.
- 10 SUBCHAPTER C. POWERS AND DUTIES
- 11 Sec. 7904A.0301. GENERAL POWERS AND DUTIES. The district
- 12 has the powers and duties necessary to accomplish the purposes for
- 13 which the district is created.
- 14 Sec. 7904A.0302. MUNICIPAL UTILITY DISTRICT POWERS AND
- 15 DUTIES. The district has the powers and duties provided by the
- 16 general law of this state, including Chapters 49 and 54, Water Code,
- 17 applicable to municipal utility districts created under Section 59,
- 18 Article XVI, Texas Constitution.
- 19 Sec. 7904A.0303. AUTHORITY FOR ROAD PROJECTS. Under
- 20 Section 52, Article III, Texas Constitution, the district may
- 21 design, acquire, construct, finance, issue bonds for, improve,
- 22 operate, maintain, and convey to this state, a county, or a
- 23 municipality for operation and maintenance macadamized, graveled,
- 24 or paved roads, or improvements, including storm drainage, in aid
- 25 of those roads.
- Sec. 7904A.0304. ROAD STANDARDS AND REQUIREMENTS. (a) A
- 27 road project must meet all applicable construction standards,

- 1 zoning and subdivision requirements, and regulations of each
- 2 municipality in whose corporate limits or extraterritorial
- 3 jurisdiction the road project is located.
- 4 (b) If a road project is not located in the corporate limits

- 6 project must meet all applicable construction standards,
- 7 subdivision requirements, and regulations of each county in which
- 8 the road project is located.
- 9 (c) If the state will maintain and operate the road, the
- 10 Texas Transportation Commission must approve the plans and
- 11 specifications of the road project.
- 12 Sec. 7904A.0305. COMPLIANCE WITH MUNICIPAL CONSENT
- 13 ORDINANCE OR RESOLUTION. The district shall comply with all
- 14 applicable requirements of any ordinance or resolution that is
- 15 <u>adopted under Section 54.016 or 54.0165</u>, Water Code, and that
- 16 consents to the creation of the district or to the inclusion of land
- 17 in the district.
- 18 Sec. 7904A.0306. PUBLIC INFORMATION. (a) The district
- 19 shall maintain an Internet website.
- 20 (b) The board shall make available on the district's
- 21 Internet website the information required under Section 26.18, Tax
- 22 Code.
- SUBCHAPTER D. BONDS AND OTHER OBLIGATIONS
- Sec. 7904A.0401. AUTHORITY TO ISSUE BONDS AND OTHER
- 25 OBLIGATIONS. The district may issue bonds or other obligations
- 26 payable wholly or partly from ad valorem taxes, impact fees,
- 27 revenue, contract payments, grants, or other district money, or any

- 1 combination of those sources, to pay for any authorized district
- 2 purpose.
- 3 Sec. 7904A.0402. TAXES FOR BONDS. At the time the district
- 4 issues bonds payable wholly or partly from ad valorem taxes, the
- 5 board shall provide for the annual imposition of a continuing
- 6 direct ad valorem tax, without limit as to rate or amount, while all
- 7 or part of the bonds are outstanding as required and in the manner
- 8 provided by Sections 54.601 and 54.602, Water Code.
- 9 Sec. 7904A.0403. BONDS FOR ROAD PROJECTS. At the time of
- 10 issuance, the total principal amount of bonds or other obligations
- 11 issued or incurred to finance road projects and payable from ad
- 12 valorem taxes may not exceed one-fourth of the assessed value of the
- 13 real property in the district.
- 14 Sec. 7904A.0404. CONSENT OF MUNICIPALITY AND DEVELOPMENT
- 15 AGREEMENT REQUIRED. (a) The temporary directors may not hold an
- 16 <u>election to authorize the issuance of bonds until:</u>
- 17 (1) the governing body of the city by ordinance or
- 18 resolution consents to the creation of the district and to the
- 19 inclusion of land in the district; and
- 20 (2) the district, the city, and the owner or owners of
- 21 a majority of the assessed value of real property in the district
- 22 negotiate and execute a mutually approved and accepted development
- 23 and operating agreement, including any limitations imposed by the
- 24 city.
- 25 (b) The city's consent under Subsection (a) must be granted
- 26 in the manner provided by Section 54.016, Water Code, for including
- 27 land within the corporate limits or extraterritorial jurisdiction
