- 12 Texas and Pacific Railway Company Surveys and having Texas State
- 13 Plane Coordinates N=10,617,593.31, E=493,881.12.
- Thence, South 02'25°56" West a distance of 1,318.09 feet to a
- 15 point;
- Thence, North 87'00°52" West a distance of 1,315.55 feet to a
- 17 found <u>5/8"" rebar;</u>
- Thence, North 02'25°56" East a distance of 1,318.04 feet to a
- 19 found 1/2" rebar with cap "2998";
- Thence, South 87'00°59" East a distance of 1315.55 feet to
- 21 "TRUE POINT OF BEGINNING" and containing in all 1,733,899 square
- 22 <u>feet or 39.8048 acres of land more or less.</u>
- 23 SECTION 2. (a) The legal notice of the intention to
- 24 introduce this Act, setting forth the general substance of this

- 1 Act, has been published as provided by law, and the notice and a
- 2 copy of this Act have been furnished to all persons, agencies,
- 3 officials, or entities to which they are required to be furnished
- 4 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 5 Government Code.
- 6 (b) The governor, one of the required recipients, has
- 7 submitted the notice and Act to the Texas Commission on
- 8 Environmental Quality.
- 9 (c) The Texas Commission on Environmental Quality has filed
- 10 its recommendations relating to this Act with the governor, the
- 11 lieutenant governor, and the speaker of the house of
- 12 representatives within the required time.
- 13 (d) All requirements of the constitution and laws of this
- 14 state and the rules and procedures of the legislature with respect
- 15 to the notice, introduction, and passage of this Act are fulfilled
- 16 and accomplished.
- 17 SECTION 3. This Act takes effect immediately if it receives
- 18 a vote of two-thirds of all the members elected to each house, as
- 19 provided by Section 39, Article III, Texas Constitution. If this
- 20 Act does not receive the vote necessary for immediate effect, this
- 21 Act takes effect September 1, 2021.
