H.B. No. 4624

A BILL TO BE ENTITLED

1 AN ACT

2 relating to the territory of the Horizon Regional Municipal Utility
3 District.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Chapter 32, Acts of the 57th Legislature, 1st
6 Called Session, 1961, is amended by adding Section 2A to read as
7 follows:

8 Sec. 2A. The following area is included in the territory of
9 the Horizon Regional Municipal Utility District:

10 "TRUE POINT OF BEGINNING" being a found 1" iron rod held for the
11 common corner of Sections 39, 38,46, and 47, Block 78, Township 3,
12 Texas and Pacific Railway Company Surveys and having Texas State
13 Plane Coordinates N=10,617,593.31, E=493,881.12.

14 Thence, South 02'25°56" West a distance of 1,318.09 feet to a
15 point;

16 Thence, North 87'00°52" West a distance of 1,315.55 feet to a
17 found 5/8"" rebar;

18 Thence, North 02'25°56" East a distance of 1,318.04 feet to a
19 found 1/2" rebar with cap "2998";

20 Thence, South 87'00°59" East a distance of 1315.55 feet to
21 "TRUE POINT OF BEGINNING" and containing in all 1,733,899 square
22 feet or 39.8048 acres of land more or less.

23 SECTION 2. (a) The legal notice of the intention to
24 introduce this Act, setting forth the general substance of this

1 Act, has been published as provided by law, and the notice and a
2 copy of this Act have been furnished to all persons, agencies,
3 officials, or entities to which they are required to be furnished
4 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
5 Government Code.

6 (b) The governor, one of the required recipients, has
7 submitted the notice and Act to the Texas Commission on
8 Environmental Quality.

9 (c) The Texas Commission on Environmental Quality has filed
10 its recommendations relating to this Act with the governor, the
11 lieutenant governor, and the speaker of the house of
12 representatives within the required time.

13 (d) All requirements of the constitution and laws of this
14 state and the rules and procedures of the legislature with respect
15 to the notice, introduction, and passage of this Act are fulfilled
16 and accomplished.

17 SECTION 3. This Act takes effect immediately if it receives
18 a vote of two-thirds of all the members elected to each house, as
19 provided by Section 39, Article III, Texas Constitution. If this
20 Act does not receive the vote necessary for immediate effect, this
21 Act takes effect September 1, 2021.
