- 22 legislative interpretation of the requirements of Section 17(c),
- 23 Article I, Texas Constitution.
- 24 SECTION 5. This Act takes effect immediately if it receives
- 25 a vote of two-thirds of all the members elected to each house, as
- 26 provided by Section 39, Article III, Texas Constitution. If this
- 27 Act does not receive the vote necessary for immediate effect, this

1 Act takes effect September 1, 2021.
