H.B. No. 4657

A BILL TO BE ENTITLED

1 AN ACT
2 relating to the creation of the Travis County Municipal Utility
3 District No. 27; granting a limited power of eminent domain;
4 providing authority to issue bonds; providing authority to impose
5 assessments, fees, and taxes.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

7 SECTION 1. Subtitle F, Title 6, Special District Local Laws
8 Code, is amended by adding Chapter 7950A to read as follows:

9 CHAPTER 7950A. TRAVIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 27

10 SUBCHAPTER A. GENERAL PROVISIONS

11 Sec. 7950A.0101. DEFINITIONS. In this chapter:

12 (1) "Board" means the district's board of directors.

13 (2) "Commission" means the Texas Commission on
14 Environmental Quality.

15 (3) "Director" means a board member.

16 (4) "District" means the Travis County Municipal
17 Utility District No. 27.

18 Sec. 7950A.0102. NATURE OF DISTRICT. The district is a
19 municipal utility district created under Section 59, Article XVI,
20 Texas Constitution.

21 Sec. 7950A.0103. CONFIRMATION AND DIRECTOR ELECTION
22 REQUIRED. The temporary directors shall hold an election to
23 confirm the creation of the district and to elect five permanent
24 directors as provided by Section 49.102, Water Code.

1 Sec. 7950A.0104. CONSENT OF MUNICIPALITY REQUIRED. The
2 temporary directors may not hold an election under Section
3 7950A.0103 until each municipality in whose corporate limits or
4 extraterritorial jurisdiction the district is located has
5 consented by ordinance or resolution to the creation of the
6 district and to the inclusion of land in the district.

7 Sec. 7950A.0105. FINDINGS OF PUBLIC PURPOSE AND BENEFIT.

8 (a) The district is created to serve a public purpose and benefit.

9 (b) The district is created to accomplish the purposes of:

10 (1) a municipal utility district as provided by
11 general law and Section 59, Article XVI, Texas Constitution; and

12 (2) Section 52, Article III, Texas Constitution, that
13 relate to the construction, acquisition, improvement, operation,
14 or maintenance of macadamized, graveled, or paved roads, or
15 improvements, including storm drainage, in aid of those roads.

16 Sec. 7950A.0106. INITIAL DISTRICT TERRITORY. (a) The
17 district is initially composed of the territory described by
18 Section 2 of the Act enacting this chapter.

19 (b) The boundaries and field notes contained in Section 2 of
20 the Act enacting this chapter form a closure. A mistake made in the
21 field notes or in copying the field notes in the legislative process
22 does not affect the district's:

23 (1) organization, existence, or validity;

24 (2) right to issue any type of bond for the purposes
25 for which the district is created or to pay the principal of and
26 interest on a bond;

27 (3) right to impose a tax; or

1 (4) legality or operation.

2 SUBCHAPTER B. BOARD OF DIRECTORS

3 Sec. 7950A.0201. GOVERNING BODY; TERMS. (a) The district
4 is governed by a board of five elected directors.

5 (b) Except as provided by Section 7950A.0202, directors
6 serve staggered four-year terms.

7 Sec. 7950A.0202. TEMPORARY DIRECTORS. (a) On or after the
8 effective date of the Act enacting this chapter, the owner or owners
9 of a majority of the assessed value of the real property in the
10 district may submit a petition to the commission requesting that
11 the commission appoint as temporary directors the five persons
12 named in the petition. The commission shall appoint as temporary
13 directors the five persons named in the petition.

14 (b) Temporary directors serve until the earlier of:

15 (1) the date permanent directors are elected under
16 Section 7950A.0103; or

17 (2) the fourth anniversary of the effective date of
18 the Act enacting this chapter.

19 (c) If permanent directors have not been elected under
20 Section 7950A.0103 and the terms of the temporary directors have
21 expired, successor temporary directors shall be appointed or
22 reappointed as provided by Subsection (d) to serve terms that
23 expire on the earlier of:

24 (1) the date permanent directors are elected under
25 Section 7950A.0103; or

26 (2) the fourth anniversary of the date of the
27 appointment or reappointment.

1 (d) If Subsection (c) applies, the owner or owners of a
2 majority of the assessed value of the real property in the district
3 may submit a petition to the commission requesting that the
4 commission appoint as successor temporary directors the five
5 persons named in the petition. The commission shall appoint as
6 successor temporary directors the five persons named in the
7 petition.

8 SUBCHAPTER C. POWERS AND DUTIES

9 Sec. 7950A.0301. GENERAL POWERS AND DUTIES. The district
10 has the powers and duties necessary to accomplish the purposes for
11 which the district is created.

12 Sec. 7950A.0302. MUNICIPAL UTILITY DISTRICT POWERS AND
13 DUTIES. The district has the powers and duties provided by the
14 general law of this state, including Chapters 49 and 54, Water Code,
15 applicable to municipal utility districts created under Section 59,
16 Article XVI, Texas Constitution.

17 Sec. 7950A.0303. AUTHORITY FOR ROAD PROJECTS. Under
18 Section 52, Article III, Texas Constitution, the district may
19 design, acquire, construct, finance, issue bonds for, improve,
20 operate, maintain, and convey to this state, a county, or a
21 municipality for operation and maintenance macadamized, graveled,
22 or paved roads, or improvements, including storm drainage, in aid
23 of those roads.

24 Sec. 7950A.0304. ROAD STANDARDS AND REQUIREMENTS. (a) A
25 road project must meet all applicable construction standards,
26 zoning and subdivision requirements, and regulations of each
27 municipality in whose corporate limits or extraterritorial

1 jurisdiction the road project is located.

2 (b) If a road project is not located in the corporate limits
3 or extraterritorial jurisdiction of a municipality, the road
4 project must meet all applicable construction standards,
5 subdivision requirements, and regulations of each county in which
6 the road project is located.

7 (c) If the state will maintain and operate the road, the
8 Texas Transportation Commission must approve the plans and
9 specifications of the road project.

10 Sec. 7950A.0305. COMPLIANCE WITH MUNICIPAL CONSENT
11 ORDINANCE OR RESOLUTION. The district shall comply with all
12 applicable requirements of any ordinance or resolution that is
13 adopted under Section 54.016 or 54.0165, Water Code, and that
14 consents to the creation of the district or to the inclusion of land
15 in the district.

16 Sec. 7950A.0306. DIVISION OF DISTRICT. (a) The district
17 may be divided into two or more new districts only if the district:

- 18 (1) has never issued any bonds; and
19 (2) is not imposing ad valorem taxes.

20 (b) This chapter applies to any new district created by the
21 division of the district, and a new district has all the powers and
22 duties of the district.

23 (c) A new district created by the division of the district
24 may not, at the time the new district is created, contain any land
25 outside the area described by Section 2 of the Act enacting this
26 chapter.

27 (d) The board, on its own motion or on receipt of a petition

1 signed by the owner or owners of a majority of the assessed value of
2 the real property in the district, may adopt an order dividing the
3 district.

4 (e) The board may adopt an order dividing the district
5 before or after the date the board holds an election under Section
6 7950A.0103 to confirm the district's creation.

7 (f) An order dividing the district shall:

8 (1) name each new district;

9 (2) include the metes and bounds description of the
10 territory of each new district;

11 (3) appoint temporary directors for each new district;

12 and

13 (4) provide for the division of assets and liabilities
14 between the new districts.

15 (g) On or before the 30th day after the date of adoption of
16 an order dividing the district, the district shall file the order
17 with the commission and record the order in the real property
18 records of each county in which the district is located.

19 (h) Any new district created by the division of the district
20 shall hold a confirmation and directors' election as required by
21 Section 7950A.0103.

22 (i) If the creation of the new district is confirmed, the
23 new district shall provide the election date and results to the
24 commission.

25 (j) Any new district created by the division of the district
26 must hold an election as required by this chapter to obtain voter
27 approval before the district may impose a maintenance tax or issue

1 bonds payable wholly or partly from ad valorem taxes.

2 (k) Municipal consent to the creation of the district and to
3 the inclusion of land in the district granted under Section
4 7950A.0104 acts as municipal consent to the creation of any new
5 district created by the division of the district and to the
6 inclusion of land in the new district.

7 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

8 Sec. 7950A.0401. ELECTIONS REGARDING TAXES OR BONDS. (a)

9 The district may issue, without an election, bonds and other
10 obligations secured by:

11 (1) revenue other than ad valorem taxes; or

12 (2) contract payments described by Section
13 7950A.0403.

14 (b) The district must hold an election in the manner
15 provided by Chapters 49 and 54, Water Code, to obtain voter approval
16 before the district may impose an ad valorem tax or issue bonds
17 payable from ad valorem taxes.

18 (c) The district may not issue bonds payable from ad valorem
19 taxes to finance a road project unless the issuance is approved by a
20 vote of a two-thirds majority of the district voters voting at an
21 election held for that purpose.

22 Sec. 7950A.0402. OPERATION AND MAINTENANCE TAX. (a) If

23 authorized at an election held under Section 7950A.0401, the
24 district may impose an operation and maintenance tax on taxable
25 property in the district in accordance with Section 49.107, Water
26 Code.

27 (b) The board shall determine the tax rate. The rate may not

1 exceed the rate approved at the election.

2 Sec. 7950A.0403. CONTRACT TAXES. (a) In accordance with
3 Section 49.108, Water Code, the district may impose a tax other than
4 an operation and maintenance tax and use the revenue derived from
5 the tax to make payments under a contract after the provisions of
6 the contract have been approved by a majority of the district voters
7 voting at an election held for that purpose.

8 (b) A contract approved by the district voters may contain a
9 provision stating that the contract may be modified or amended by
10 the board without further voter approval.

11 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS

12 Sec. 7950A.0501. AUTHORITY TO ISSUE BONDS AND OTHER
13 OBLIGATIONS. The district may issue bonds or other obligations
14 payable wholly or partly from ad valorem taxes, impact fees,
15 revenue, contract payments, grants, or other district money, or any
16 combination of those sources, to pay for any authorized district
17 purpose.

18 Sec. 7950A.0502. TAXES FOR BONDS. At the time the district
19 issues bonds payable wholly or partly from ad valorem taxes, the
20 board shall provide for the annual imposition of a continuing
21 direct ad valorem tax, without limit as to rate or amount, while all
22 or part of the bonds are outstanding as required and in the manner
23 provided by Sections 54.601 and 54.602, Water Code.

24 Sec. 7950A.0503. BONDS FOR ROAD PROJECTS. At the time of
25 issuance, the total principal amount of bonds or other obligations
26 issued or incurred to finance road projects and payable from ad
27 valorem taxes may not exceed one-fourth of the assessed value of the

1 real property in the district.

2 SECTION 2. The Travis County Municipal Utility District
3 No. 27 initially includes all the territory contained in the
4 following area:

8 THE CALLED 91.97 ACRE TRACT (FIRST TRACT), 80 ACRE TRACT (THIRD
9 TRACT), 40.97 ACRE TRACT (FIFTH TRACT) AND PORTIONS OF THE CALLED
10 148.03 ACRE TRACT (SECOND TRACT) AND 330 ACRE TRACT (FOURTH TRACT)
11 OF LAND AS CONVEYED TO HOLMES FAMILY PROPERTIES, LTD. BY SPECIAL
12 WARRANTY DEEDS RECORDED IN VOLUME 12733, PAGE 826 AND VOLUME 13019,
13 PAGE 1028 OF THE REAL PROPERTY RECORDS OF TRAVIS COUNTY, TEXAS;
14 SAID 479.689 ACRE TRACT OF LAND BEING MORE PARTICULARLY DESCRIBED
15 BY METES AND BOUNDS AS FOLLOWS:

16 BEGINNING at a 1/2-inch iron pipe found on the northerly
17 right-of-way line of Bee Creek Road (a public roadway) as described
18 in Travis County Commissioners Court Road Book Number 3, Pages
19 460-481, at the southeast corner of BRIARCLIFF, INC., SECTION 14, a
20 subdivision as recorded in Volume 49, Page 21 of the Plat Records of
21 Travis County, Texas, for the southwest corner and POINT OF
22 BEGINNING of the herein described tract;

23 THENCE, with the east line of said BRIARCLIFF, SECTION 14, N
24 29°13'42" E a distance of 2,698.71 feet to a 1/2-inch iron rod found
25 on the easterly right-of-way of S. Cowal Drive (60' ROW), for an
26 angle point of the herein described tract;

27 THENCE, with the east right-of-way of said S. Cowal Drive, N

1 29°14'10" E a distance of 1,191.95 feet to a 1/2-inch iron rod found
2 for an angle point of the herein described tract;

3 THENCE, with the east line of BRIARCLIFF, INC., SECTION 16, a
4 subdivision as recorded in Volume 43, Page 37 of the Plat Records of
5 Travis County, Texas, N 29°13'58" E a distance of 2,831.88 feet to a
6 1/2-inch iron rod with cap stamped "BGE INC" set for an angle point
7 of the herein described tract;

8 THENCE, continuing with the east line of said BRIARCLIFF,
9 SECTION 16, N 27°23'59" E a distance of 818.51 feet to a 1/2-inch
10 iron rod with cap stamped "BGE INC" set for an angle point of the
11 herein described tract;

12 THENCE, with the east line of BRIARCLIFF, INC., SECTION 8, a
13 subdivision as recorded in Volume 37, Page 36 of the Plat Records of
14 Travis County, Texas, N 24°52'52" E a distance of 690.22 feet to a
15 1/2-inch iron rod with cap stamped "BGE INC" set for an angle point
16 of the herein described tract;

17 THENCE, continuing with the east line of said BRIARCLIFF,
18 SECTION 8, N 24°25'53" W a distance of 34.88 feet to a 1/2-inch iron
19 rod with cap stamped "BGE INC" set for an angle point of the herein
20 described tract;

21 THENCE, continuing with the east line of said BRIARCLIFF,
22 SECTION 8, N 26°32'24" E distance of 994.15 feet to a 1/2-inch iron
23 rod found on the east line of BRIARCLIFF, SECTION 4, a subdivision
24 as recorded in Volume 35, Page 27 of the Plat Records of Travis
25 County, Texas, for an angle point of the herein described tract;

26 THENCE, with the east line of said BRIARCLIFF, SECTION 4, N
27 26°27'59" E, pass a 1/2-inch iron rod found at the common east corner

1 of Lots 836 & 837, both of said BRIARCLIFF, SECTION 4 at a distance
2 of 947.98 feet, and continuing on for a total distance of 1,300.74
3 feet to a calculated point (inundated) on the approximate south
4 bank of the Colorado River;

5 THENCE, with the approximate south bank of the Colorado
6 River, the following five (5) courses:

7 1) S 61°58'44" E a distance of 325.40 feet to a calculated
8 angle point (inundated);

9 2) S 73°06'44" E a distance of 576.30 feet to a calculated
10 angle point (inundated);

23 Records of Travis County, Texas at a distance of 267.31 feet, and

7 THENCE, continuing with the westerly line of said LAKEWOOD
8 ESTATES, S 27°56'46" W a distance of 139.27 feet to a 1/2-inch iron
9 rod found at the southwest corner of said Lot 121, and the northwest
10 corner of a called 55.355 acre tract as conveyed to David N. Leonard
11 and Beverly K. Leonard by deed recorded in Document Number
12 1999032790 of the Official Public Records of Travis County, Texas,
13 for an angle point of the herein described tract;

14 THENCE, with the westerly line of said 55.355 acre tract, S
15 28°46'18" W a distance of 2,694.96 feet to a 1/2-inch iron rod with
16 cap stamped "BGE INC" set on the northwesterly right-of-way line of
17 Thurman Bend Drive (variable width R.O.W.) at the most southerly
18 corner of said 55.355 acre tract, also being the most northerly
19 corner of a called 17.19 acre tract (Tract 4) as conveyed to Duke
20 Covert, Rox Covert and Danay Covert by deed recorded in Document
21 Number 2009148814 of the Official Public Records of Travis County,

14 THENCE N 61°39'04" W a distance of 10.45 feet to a 1/2-inch
15 iron rod with cap stamped "BGE INC" set on the fence line, for an
16 angle point of the herein described tract;

17 THENCE, with the westerly right-of-way line of Thurman Bend
18 Road, as fenced and occupied, the following sixty-three (63)
19 courses:

15 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
16 Government Code.

17 (b) The governor, one of the required recipients, has
18 submitted the notice and Act to the Texas Commission on
19 Environmental Quality.

20 (c) The Texas Commission on Environmental Quality has filed
21 its recommendations relating to this Act with the governor, the
22 lieutenant governor, and the speaker of the house of
23 representatives within the required time.

24 (d) All requirements of the constitution and laws of this
25 state and the rules and procedures of the legislature with respect
26 to the notice, introduction, and passage of this Act are fulfilled
27 and accomplished.

1 SECTION 4. (a) If this Act does not receive a two-thirds
2 vote of all the members elected to each house, Subchapter C, Chapter
3 7950A, Special District Local Laws Code, as added by Section 1 of
4 this Act, is amended by adding Section 7950A.0307 to read as
5 follows:

6 Sec. 7950A.0307. NO EMINENT DOMAIN POWER. The district may
7 not exercise the power of eminent domain.

8 (b) This section is not intended to be an expression of a
9 legislative interpretation of the requirements of Section 17(c),
10 Article I, Texas Constitution.

11 SECTION 5. This Act takes effect immediately if it receives
12 a vote of two-thirds of all the members elected to each house, as
13 provided by Section 39, Article III, Texas Constitution. If this
14 Act does not receive the vote necessary for immediate effect, this
15 Act takes effect September 1, 2021.
