## HOUSE CONCURRENT RESOLUTION

- 1 WHEREAS, The increasing military capabilities of other
- 2 nations pose a growing threat to the United States, and in response,
- 3 the U.S. military is undertaking critical modernization efforts
- 4 across all branches; and
- 5 WHEREAS, The U.S. Army has adopted a modernization plan
- 6 encompassing six mutually supporting priorities, among them the
- 7 Future Vertical Lift program; the FVL initiative is a research and
- 8 development effort to provide the next generation of rotorcraft
- 9 technology to the armed forces, improving maneuverability, range,
- 10 speed, payload, survivability, and reliability while reducing
- 11 logistical footprint; and
- WHEREAS, Key components of FVL include the Future Long-Range
- 13 Assault Aircraft and Future Attack Reconnaissance Aircraft; FARA is
- 14 designed to defeat defensive layers by providing much-needed aerial
- 15 reconnaissance capabilities, while FLRAA will exploit opened areas
- 16 to achieve air assault, air medical, and medium utility missions;
- 17 and
- 18 WHEREAS, FVL will enable the Army National Guard, including
- 19 the Texas National Guard, to expand its mission as an operational
- 20 strategic reserve; and
- 21 WHEREAS, Army Futures Command, headquartered in Austin,
- 22 focuses on modernization and speeding up the acquisition of
- 23 platforms and technology, including FVL; Texas is both a center of
- 24 the nation's aerospace and aviation industry and home to active

- 1 military bases representing all branches of the military; moreover,
- 2 numerous defense contractors and suppliers located in the Lone Star
- 3 State play a role in strengthening military readiness; and
- WHEREAS, FVL is vital to the military's ability to compete in
- 5 the ever-evolving threat environment, and this important program
- 6 will also promote continued growth and innovation in the aerospace
- 7 and defense sectors in Texas and the nation; now, therefore, be it

- 9 hereby express its support for the Future Vertical Lift program,
- 10 including FLRAA and FARA, as part of U.S. Army modernization; and,

- 14 Vertical Lift program, including the Future Long-Range Assault
