## HOUSE CONCURRENT RESOLUTION

- 1 WHEREAS, The Honorable Ramon Garcia has contributed greatly
- 2 to his fellow citizens through his long and dedicated service as
- 3 Hidalgo County judge; and
- WHEREAS, A native of McAllen, Mr. Garcia knew from an early
- 5 age that he wanted to pursue a career in law; after earning his
- 6 bachelor's degree from Pan American University in 1970, he
- 7 graduated with honors from the Bates College of Law at the
- 8 University of Houston in 1972, passing the State Bar exam that same
- 9 year; and
- 10 WHEREAS, Early in his 40-year career, Mr. Garcia earned a
- 11 reputation as one of the best criminal defense attorneys in South
- 12 Texas, and he went on to enjoy equal success as a personal injury
- 13 attorney; over the years, he has tried more than 200 cases before
- 14 juries and recovered hundreds of millions of dollars for plaintiffs
- 15 across Texas; and
- WHEREAS, In 2002, Mr. Garcia was elected as Hidalgo County
- 17 judge, and he donated his entire salary from his first term to
- 18 charity; he held the position for a total of three terms until his
- 19 retirement in December 2018, making him the longest-serving county
- 20 judge in the county's history; over the course of his tenure in
- 21 office, he worked to increase the county's reserve funds from
- 22 \$710,000 to \$38 million, and he also led the effort to build a new
- 23 Hidalgo County courthouse; and
- 24 WHEREAS, Judge Garcia is the recipient of numerous honors,

- 1 including the Valley Hispanic Award from The University of
- 2 Texas-Pan American Library, the Golden Eagle Award from the McAllen
- 3 Hispanic Chamber of Commerce, the Hispanic Exemplary Award from El
- 4 Americano News, the Governor's Humanitarian Achievement Award from
- 5 Rio Grande Valley Humanities, and the Pillars of Success Award from
- 6 The University of Texas-Pan American; in 2019, the law library of
- 7 the new Hidalgo County Courthouse was dedicated in his honor; and
- 8 WHEREAS, Through his vision, leadership, and expertise,
- 9 Ramon Garcia has contributed immeasurably to his community, and in
- 10 so doing, he has earned the lasting respect and appreciation of his
- 11 fellow citizens; now, therefore, be it
- 12 RESOLVED, That the 87th Legislature of the State of Texas
- 13 hereby commend Ramon Garcia for his service as Hidalgo County judge
- 14 and extend to him sincere best wishes for the future; and, be it
