H.J.R. No. 57

A JOINT RESOLUTION

1 proposing a constitutional amendment authorizing the legislature 2 to exempt from ad valorem taxation real property leased to certain 3 schools organized and operated primarily for the purpose of 4 engaging in educational functions.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:
SECTION 1. Section 2(a), Article VIII, Texas Constitution,
is amended to read as follows:

8 (a) All occupation taxes shall be equal and uniform upon the 9 same class of subjects within the limits of the authority levying the tax; but the legislature may, by general laws, exempt from 10 taxation public property used for public purposes; actual places of 11 12 religious worship, also any property owned by a church or by a strictly religious society for the exclusive use as a dwelling 13 place for the ministry of such church or religious society, and 14 which yields no revenue whatever to such church or religious 15 16 society; provided that such exemption shall not extend to more property than is reasonably necessary for a dwelling place and in no 17 event more than one acre of land; any property owned by a church or 18 by a strictly religious society that owns an actual place of 19 religious worship if the property is owned for the purpose of 20 21 expansion of the place of religious worship or construction of a new place of religious worship and the property yields no revenue 22 23 whatever to the church or religious society, provided that the legislature by general law may provide eligibility limitations for 24

1 the exemption and may impose sanctions related to the exemption in furtherance of the taxation policy of this subsection; any property 2 3 that is owned by a church or by a strictly religious society and is leased by that church or strictly religious society to a person for 4 5 use as a school, as defined by Section 11.21, Tax Code, or a successor statute, for educational purposes; any real property that 6 is leased to a person for use as a school that operates under a 7 8 charter granted by the State Board of Education, the commissioner of education, or any other state agency or officer and that is 9 qualified as provided by Section 11.21, Tax Code, or a successor 10 statute; places of burial not held for private or corporate profit; 11 12 solar or wind-powered energy devices; all buildings used exclusively and owned by persons or associations of persons for 13 14 school purposes and the necessary furniture of all schools and 15 property used exclusively and reasonably necessary in conducting any association engaged in promoting the religious, educational and 16 17 physical development of boys, girls, young men or young women operating under a State or National organization of like character; 18 also the endowment funds of such institutions of learning and 19 religion not used with a view to profit; and when the same are 20 invested in bonds or mortgages, or in land or other property which 21 has been and shall hereafter be bought in by such institutions under 22 foreclosure sales made to satisfy or protect such bonds or 23 24 mortgages, that such exemption of such land and property shall continue only for two years after the purchase of the same at such 25 26 sale by such institutions and no longer, and institutions engaged primarily in public charitable functions, which may conduct 27

1 auxiliary activities to support those charitable functions; and all 2 laws exempting property from taxation other than the property 3 mentioned in this Section shall be null and void.

4 SECTION 2. The following temporary provision is added to 5 the Texas Constitution:

6 <u>TEMPORARY PROVISION. (a) This temporary provision applies</u> 7 <u>to the constitutional amendment proposed by the 87th Legislature,</u> 8 <u>Regular Session, 2021, authorizing the legislature to exempt from</u> 9 <u>ad valorem taxation real property leased to certain schools</u> 10 <u>organized and operated primarily for the purpose of engaging in</u> 11 <u>educational functions.</u>

12 (b) The amendment to Section 2(a), Article VIII, of this 13 constitution takes effect beginning with the tax year that begins 14 January 1, 2022.

(c) This temporary provision expires January 1, 2023.

16 SECTION 3. This proposed constitutional amendment shall be 17 submitted to the voters at an election to be held November 2, 2021. The ballot shall be printed to permit voting for or against the 18 constitutional amendment authorizing 19 proposition: "The the legislature to exempt from ad valorem taxation real property leased 20 to certain schools organized and operated primarily for the purpose 21 of engaging in educational functions." 22
