A JOINT RESOLUTION

- 1 proposing a constitutional amendment requiring the lieutenant
- 2 governor and speaker of the house of representatives to call the
- 3 legislature into special session on petition of at least two-thirds
- 4 of the members of each house of the legislature in response to a
- 5 fiscal crisis, war, natural disaster, or emergency.
- 6 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Article III, Texas Constitution, is amended by
- 8 adding Section 5A to read as follows:
- 9 Sec. 5A. The lieutenant governor and speaker of the house of
- 10 representatives shall by joint proclamation convene the
- 11 legislature in special session on receipt of a petition that is
- 12 signed by at least two-thirds of the members of each house of the
- 13 <u>legislature requesting the special session for the purpose of</u>
- 14 responding to a fiscal crisis, war, natural disaster, or emergency.
- 15 The proclamation must provide for convening the legislature not
- 16 later than the 60th day after the date the lieutenant governor and
- 17 speaker of the house of representatives receive the petition.
- 18 SECTION 2. Section 40, Article III, Texas Constitution, is
- 19 amended to read as follows:
- Sec. 40. (a) When the <u>legislature is</u> [Legislature shall be]
- 21 convened in <u>a</u> special session <u>called</u> by the governor as authorized
- 22 by Section 8, Article IV, of this constitution, the legislature may
- 23 not consider [there shall be no] legislation on a subject [upon
- 24 subjects] other than a subject [those] designated in the

- 1 proclamation of the governor [Governor] calling the [such] session,
- 2 or presented to the legislature [them] by the governor.
- 3 (b) When the legislature is convened in a special session
- 4 required by Section 5A of this article, the legislature may not
- 5 consider legislation on a subject other than a subject directly
- 6 related to the state's response to the fiscal crisis, war, natural
- 7 disaster, or emergency for which the special session is convened.
- 8 <u>(c) No special</u> [Governor; and no such] session shall be of 9 longer duration than thirty days.
- 10 SECTION 3. This proposed constitutional amendment shall be
- 11 submitted to the voters at an election to be held November 2, 2021.
- 12 The ballot shall be printed to permit voting for or against the
- 13 proposition: "The constitutional amendment requiring the
- 14 lieutenant governor and speaker of the house of representatives to
- 15 call the legislature into special session on petition of at least
- 16 two-thirds of the members of each house of the legislature in
- 17 response to a fiscal crisis, war, natural disaster, or emergency."
