A JOINT RESOLUTION

- 1 proposing a constitutional amendment authorizing the professional
- 2 sports team charitable foundations of organizations sanctioned by
- 3 the Professional Rodeo Cowboys Association to conduct charitable
- 4 raffles at rodeo venues.
- 5 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 47(d-1), Article III, Texas
- 7 Constitution, is amended to read as follows:
- 8 (d-1) The legislature by general law may permit a
- 9 professional sports team charitable foundation to conduct
- 10 charitable raffles under the terms and conditions imposed by
- 11 general law. The law may authorize the charitable foundation to pay
- 12 with the raffle proceeds reasonable advertising, promotional, and
- 13 administrative expenses. A law enacted under this subsection
- 14 applies only to an entity defined as a professional sports team
- 15 charitable foundation under that law and may only allow charitable
- 16 raffles to be conducted at games or rodeo events hosted at the home
- 17 venue of the professional sports team associated with a
- 18 professional sports team charitable foundation. In this
- 19 subsection, "professional sports team" means:
- 20 (1) a team organized in this state that is a member of
- 21 Major League Baseball, the National Basketball Association, the
- 22 National Hockey League, the National Football League, Major League
- 23 Soccer, the American Hockey League, the East Coast Hockey League,
- 24 the American Association of Independent Professional Baseball, the

- 1 Atlantic League of Professional Baseball, Minor League Baseball,
- 2 the National Basketball Association Development League, the
- 3 National Women's Soccer League, the Major Arena Soccer League, the
- 4 United Soccer League, or the Women's National Basketball
- 5 Association;
- 6 (2) a person hosting a motorsports racing team event
- 7 sanctioned by the National Association for Stock Car Auto Racing
- 8 (NASCAR), INDYCar, or another nationally recognized motorsports
- 9 racing association at a venue in this state with a permanent seating
- 10 capacity of not less than 75,000;
- 11 (3) an organization hosting a Professional Golf
- 12 Association event; [or]
- 13 (4) <u>an organization sanctioned by the Professional</u>
- 14 Rodeo Cowboys Association; or
- 15 <u>(5)</u> any other professional sports team defined by law.
- 16 SECTION 2. This proposed constitutional amendment shall be
- 17 submitted to the voters at an election to be held November 2, 2021.
- 18 The ballot shall be printed to provide for voting for or against the
- 19 proposition: "The constitutional amendment authorizing the
- 20 professional sports team charitable foundations of organizations
- 21 sanctioned by the Professional Rodeo Cowboys Association to conduct
- 22 charitable raffles at rodeo venues."
