1           WHEREAS, The death of Menard County Judge Richard Allen  
2 Cordes on February 15, 2020, at the age of 68, brought a great loss  
3 to his family, friends, and fellow citizens; and

4           WHEREAS, Born to Oney and Verna Cordes on January 25, 1952,  
5 Richard Cordes grew up with three brothers, John, Greg, and Oney,  
6 and three sisters, Laurie, Wanda, and Donna; he graduated from  
7 Texas A&M University College of Veterinary Medicine and went on to  
8 serve his country in the United States Air Force for three years; in  
9 1978, he and his wife, Janis, moved to Menard and purchased Menard  
10 Animal Clinic; treating both pets and livestock, Dr. Cordes became  
11 widely known in the Hill Country for his kindness, expertise, and  
12 ability to calm nervous animals, and he also delighted clients with  
13 his sense of humor; he was involved with local youth who showed  
14 livestock, and he benefited his profession as a member of the Texas  
15 Department of Licensing and Regulation's Licensed Breeder Advisory  
16 Committee; and

17           WHEREAS, Dr. Cordes was a county commissioner from 1986 to  
18 1998 and served as county judge from 2003 until his passing; he  
19 brought to his work compassion, humility, and integrity, as well as  
20 a sharp intellect; active in the Concho Valley Council of  
21 Governments, he served as secretary, vice president, and president,  
22 and he was also president of the Concho Valley Community Action  
23 Agency; in addition, he was a director of the Frontera Healthcare  
24 Network and a member of the Texas Small Business Development Center

1 and the Texas Rural Foundation; he was named 2007 Official of the  
2 Year by the West Texas County Judges and Commissioners Association,  
3 and he was twice named Menard's Citizen of the Year; and

4 WHEREAS, Devoted to his loved ones, Dr. Cordes leaves to  
5 cherish his memory his wife, Janis, and their children: Megan  
6 Cordes and family, Brittany and Cai Laird; Blane Cordes and family,  
7 Ashlea, Avery, Weston, and Aubrey; and Logan Cordes and family,  
8 Anna, Cam, Allie, and Kason, as well as his siblings, Greg Cordes,  
9 Laurie Curtis, Oney Cordes, Wanda Baldwin, and Donna Shodrock; and

10 WHEREAS, Richard Cordes made a lasting, positive difference  
11 in his community through his outstanding professional and civic  
12 contributions, and although he is deeply missed by those he left  
13 behind, he will forever hold a special place in their hearts; now,  
14 therefore, be it

15 RESOLVED, That the House of Representatives of the 87th Texas  
16 Legislature hereby pay tribute to the life of Dr. Richard Allen  
17 Cordes and extend sincere condolences to all who mourn his passing;
