1 WHEREAS, Family and friends will forever treasure their
2 memories of Frederic William "Tony" Hall of Kimble County, who
3 passed away on November 8, 2020, at the age of 81; and

4 WHEREAS, Tony Hall was born in San Angelo to Fred and Martha
5 Hall on July 13, 1939, and he grew up in Eden with four siblings,
6 Edwin, David, Nancy, and Diane; in 1963, he married Jane Mears, and
7 he became the proud father of two sons, Stephen and Andrew; after
8 his first wife passed away in 1992, he was fortunate to find love
9 again with his second wife, Judy Black Hall; he had the pleasure of
10 welcoming into his family two stepsons, Ira and Clay, as well as
11 three grandchildren, Carson, Grant, and Claire; and

12 WHEREAS, Following his graduation from Texas A&M University
13 in 1961, Mr. Hall enlisted in the U.S. Army and served in a field
14 artillery unit in Bad Kissingen, Germany; returning to civilian
15 life, he briefly worked as the administrator of the Concho County
16 Hospital in Eden before earning a master's degree in health care
17 administration from Trinity University in San Antonio; after
18 completing a residency at Scott and White Hospital in Temple, he
19 served for five years as assistant hospital administrator at
20 Midland Memorial Hospital and for 25 years as the CEO of Sid
21 Peterson Memorial Hospital in Kerrville; and

22 WHEREAS, During his years in Kerrville, Mr. Hall was active
23 with First United Methodist Church and several civic organizations,
24 and after retiring to a ranch near Junction, he continued to serve

1 his community through his involvement with the Kimble County Soil
2 and Water Conservation District, the Kimble County Prescribed Burn
3 Association, the Kimble County Hospital Foundation Board, and First
4 United Methodist Church of Junction; and

5 WHEREAS, A devoted family man, a respected professional, and
6 an engaged citizen, Tony Hall lived a caring and purposeful life,
7 and he leaves behind a record of service that his loved ones can
8 remember with pride; now, therefore, be it

9 RESOLVED, That the House of Representatives of the 87th Texas
10 Legislature hereby pay tribute to the memory of Frederic William
11 Hall and extend heartfelt sympathy to all who mourn his passing;
