- 1 WHEREAS, Eric Fagan was sworn in as the 43rd sheriff of Fort
- 2 Bend County on January 1, 2021, becoming the first African American
- 3 to be elected sheriff in the county since Reconstruction, 151 years
- 4 ago; and
- 5 WHEREAS, A graduate of Prairie View A&M University, Sheriff
- 6 Fagan earned his bachelor's degree in criminal justice and a
- 7 master's degree in juvenile forensic psychology; while working
- 8 toward his master's degree, he performed psychological evaluations
- 9 of inmates under the supervision of a licensed psychiatrist before
- 10 their court appearances; and
- 11 WHEREAS, Sheriff Fagan went on to a remarkable 31-year tenure
- 12 with the Houston Police Department, where he was recognized as
- 13 Officer of the Year three times; he served as a mediator and
- 14 facilitator in the Alternative Dispute Resolution section of the
- 15 Internal Affairs Division, achieving a 100 percent agreement rate
- 16 in more than 200 cases; and
- WHEREAS, A leader in his profession, Sheriff Fagan is the
- 18 president emeritus of the African American Police Officer's League;
- 19 in addition, he was a member of Mayor Sylvester Turner's protection
- 20 detail, and he has been certified in dignitary protection by the
- 21 Texas Department of Public Safety; during Super Bowl LI, he worked
- 22 with the NFL's security team, the FBI, the U.S. Department of
- 23 Homeland Security, the Harris County Sheriff's Office, and other
- 24 agencies to help plan for the event; and
