11 County before working for Lampasas and Mills Counties; a leader in
12 his profession, he earned numerous accolades over the years; he was

14 Department and received recognition from Shikar Safaris; in
15 addition, he was a charter member of the Texas Game Warden
16 Association; and

18 the love and support of his wife, Sharon, with whom he shared a
19 rewarding union of 57 years; he took great pride in his sons,
20 Richard and Timothy, and with the passing years, he had the pleasure

22 lover, Mr. Pinckney raised thoroughbred race horses and enjoyed the
23 companionship of his miniature schnauzer, Heidi; and
