

R E S O L U T I O N

1 WHEREAS, The citizens of Wise County lost a beloved resident
2 and civic leader with the passing of the Honorable Melton David Cude
3 on November 29, 2020, at the age of 65; and

4 WHEREAS, Melton Cude was born in Decatur on June 22, 1955, to
5 Milvern and Margaret Cude, and he grew up with a brother, Murray; he
6 was a member of the Class of 1973 at Decatur High School and
7 graduated with highest honors from Texas A&M University; in 1980,
8 he earned a juris doctor degree from Baylor Law; he began his career
9 as an attorney with the Decatur law firm of Woodruff, Fostel, Wren,
10 and Simpson; and

11 WHEREAS, A dedicated public servant, Mr. Cude was the
12 presiding judge of Wise County Court at Law No. 1 and was fulfilling
13 his ninth elected term at the time of his death; in total, he served
14 more than three decades, becoming one of the longest-tenured
15 elected officials in the county; for eight years, he also held the
16 title of judge advocate general with the Texas Army National Guard;

18 WHEREAS, In all his endeavors, Judge Cude enjoyed the love
19 and support of his wife, Arlena, with whom he shared a rewarding
20 marriage that spanned nearly four decades; he was the devoted
21 father of two children, David and Amy, and he took great pride in
22 his three grandchildren; a man of faith, he was a lifelong member of
23 First Baptist Church of Decatur, and he was actively engaged with
24 his community; and

1 WHEREAS, Although the untimely death of Judge Melton Cude has
2 brought profound sorrow to all who were privileged to know him, his
3 integrity and commitment to service will remain a lasting source of
4 inspiration; now, therefore, be it

5 RESOLVED, That the House of Representatives of the 87th Texas
6 Legislature hereby pay tribute to the memory of Judge Melton David
7 Cude and extend deepest condolences to the members of his family: to
8 his wife, Arlena Cude; to his son, David Cude, and his wife,
9 Kristen; to his daughter, Amy Casares, and her husband, Noe; to his
10 grandchildren, Evanglynhnn and Nehemiah Casares and Jireh Grace
11 Cude; to his brother, Murray Cude; to his father-in-law, J. L.
12 Hesteande; and to his many other relatives and friends; and, be it
