- 2 passing of Welborn Boyd Harris Jr. of Lubbock on January 2, 2021, at
- 3 the age of 93; and
- WHEREAS, The son of Welborn B. Harris Sr. and Callie Lee
- 5 Cissel Harris, "Dub" Harris was born on December 8, 1927, in
- 6 Morganfield, Kentucky, and he grew up with the companionship of two
- 7 sisters, Callie and Florence; after graduating from Union County
- 8 High School, he joined the U.S. Air Force; a staff sergeant, he
- 9 served as a meteorologist with the postwar U.S. occupation forces
- 10 in Japan, and he was discharged in 1948; later, he moved to Lubbock
- 11 and earned his degree in business administration at Texas Tech
- 12 University; and
- WHEREAS, Mr. Harris remained in Texas and worked in real
- 14 estate until 1957, when he accepted a position with a subsidiary of
- 15 the Westinghouse Corporation that transferred him to several
- 16 locations throughout the U.S.; he returned to Lubbock in 1964 as the
- 17 dealer principal at Hub Motor Company, and he was subsequently
- 18 employed by Lubbock Methodist Hospital as vice president of
- 19 development; in 1972, he became the first development officer for
- 20 the Texas Tech University Health Sciences Center, and he later
- 21 became a licensed real estate appraiser, ultimately retiring at the
- 22 age of 86; and
- WHEREAS, A man of deep faith, Mr. Harris taught Sunday school
- 24 at First United Methodist Church of Lubbock, and he was a charter

- 1 member of St. Luke's Lubbock, which he helped organize; in
- 2 addition, he was a former president of the Lubbock Country Club, and
- 3 he was a member of the Greater Southwest Lubbock Rotary Club and the
- 4 Texas Tech Alumni Association; and
- 5 WHEREAS, In all his endeavors, Mr. Harris enjoyed the love
- 6 and support of his wife, Denece, with whom he shared a rewarding
- 7 marriage of more than seven decades; he was the devoted father of
- 8 two daughters, Kitty and Linn, and he took great pride in his four
- 9 grandchildren and seven great-grandchildren; and
- 10 WHEREAS, Although Dub Harris will be deeply missed, he has
- 11 left his family and friends with a wealth of memories that they will
- 12 forever treasure; now, therefore, be it
