- 3 on December 12, 2020, at the age of 77; and
- WHEREAS, Born in Rankin to Angela and Lasaro Abalos on July 4,
- 5 1943, Richard Abalos grew up with 14 siblings, Paul, Basilio,
- 6 Eustolia, Frank, Lasaro, Rosendo, George, Jesse, Johnny, Selso,
- 7 Lupe, Linda, Martha, and Victoria; he learned the value of hard work
- 8 at an early age, laboring with his family in the cotton and onion
- 9 fields of West Texas, and in junior high school, he started his own
- 10 business filling out tax forms; his skill as a Golden Gloves boxer
- 11 led him to find a job in the office of attorney Warren Burnett, who
- 12 helped him enroll in The University of Texas and St. Mary's
- 13 University School of Law; and
- 14 WHEREAS, Mr. Abalos served in the U.S. Army during the
- 15 Vietnam War with the Judge Advocate General's Corps at Fort Rucker,
- 16 Alabama, where he bunked with future vice president Al Gore;
- 17 returning to civilian life, he joined Mr. Burnett's law firm as one
- 18 of the first Mexican American lawyers in Odessa, and he went on to
- 19 enjoy a legal career that spanned nearly half a century, starting
- 20 his own law firm and winning a reputation as a skilled and
- 21 determined advocate for his clients; and
- WHEREAS, Throughout his life, Mr. Abalos participated in the
- 23 Democratic Party on the state and local levels, and as a proud
- 24 Mexican American, he was active with the League of United Latin

- 1 American Citizens and Hispanic Heritage; moreover, he was a
- 2 founding member of the Club Los Dorados riding club; he was the
- 3 recipient of many accolades, including the Community Statesman
- 4 Award from the Heritage of Odessa Foundation and the Odessa
- 5 American; in his leisure time, he delighted in riding horses,
- 6 sharing happy hour with his fellow attorneys, rooting for the
- 7 Dallas Cowboys, collecting coins, bird-watching, and playing
- 8 chess, tennis, and poker; and
- 9 WHEREAS, Mr. Abalos was a loving and supportive husband to
- 10 Delma, his wife of 42 years, and he took great pride in his three
- 11 children, Angel, Feliz, and Andrea, and his two grandchildren, Noah
- 12 and Lyndon; he was also a loving brother and uncle, and a true and
- 13 loyal friend, generously sharing his time and resources with anyone
- 14 in need; and
- WHEREAS, A devoted family man, a respected attorney, and an
- 16 engaged member of his community, Richard Abalos leaves behind a
- 17 record of service that his loved ones can remember with pride; now,
- 18 therefore, be it
