- 1 WHEREAS, Jimmie B. Todd of Odessa passed away on September 1,
- 2 2020, at the age of 82, leaving behind a legacy that will forever be
- 3 treasured by his loved ones, friends, and colleagues; and
- WHEREAS, Born to Mary Britton and Jack Todd in 1937, Jimmie
- 5 Todd grew up in Perryton with the companionship of a sister, Jayne;
- 6 after graduating from Perryton High School, he attended Texas
- 7 Christian University and earned his bachelor's degree in accounting
- 8 in 1960; while there, he played on the TCU football teams that
- 9 advanced to the Southwest Conference Championship in 1956 and 1959;
- 10 he received his doctor of jurisprudence degree from The University
- 11 of Texas and was licensed as a certified public accountant in 1964;

- WHEREAS, Mr. Todd began his legal career in Odessa as a
- 14 member of the law firm of Deaderick, McMahon and McKim, which later
- 15 became McMahon, Cox, Todd and Tidwell; in 1978, he established his
- 16 own law firm, which is today known as Todd, Barron, Thomason, Hudman
- 17 & Bebout, P.C.; a member of the Odessa Area Bar Association, he
- 18 served as a legal advisor to many businesses in the Permian Basin
- 19 area; in addition to his achievements as a legal professional, he
- 20 guided E. L. Farmer & Company as its president from 2002 to 2013 and
- 21 served as director of State National Bank from 1977 to 1988 and
- 22 Western National Bank from 1989 to 2015; and
- WHEREAS, Over the years, Mr. Todd also found time to give
- 24 back to his community; as a member of the Odessa Chamber of

- 1 Commerce, he helped bring The University of Texas Permian Basin to
- 2 the city, and he was a founder and trustee of the Village Place
- 3 Charitable Trust; other organizations that benefited from his
- 4 contributions included the Boys Club of Odessa, the Permian Basin
- 5 Rehabilitation Center, the Odessa Downtown Lions Club, United Way
- 6 of Odessa, and the Odessa College Foundation; moreover, he
- 7 volunteered in many different capacities at First Baptist Church
- 8 during his 57-year membership; and
- 9 WHEREAS, Mr. Todd shared a rewarding marriage with his wife,
- 10 Ann Todd, that spanned six decades, and he took great pride in his
- 11 daughter, Mary, and his grandchildren, Zachary, Jarrod, and Hope;
- 12 he was preceded in death by his sons, Michael and John, and his
- 13 granddaughter, Brittony; and
- 14 WHEREAS, Although the passing of Jimmie Todd has greatly
- 15 saddened those who knew and loved him, they will continue to find
- 16 inspiration in his unwavering devotion to his family, his
- 17 profession, and his community; now, therefore, be it
