20 WHEREAS, Working alongside program coordinator Idalia Mejia, 21 Dr. Villalobos leads the Center of Excellence in STEM Education in 22 supporting and providing resources to students who are pursuing 23 careers in STEM fields; one of the center's goals is to increase the 24 number of STEM graduates, especially those from minority groups,
