1           WHEREAS, Family and friends are mourning the loss of Duane  
2 Francis Snell of Lamesa, who died on March 13, 2021, at the age of  
3 73; and

4           WHEREAS, Duane Snell was born in Lamesa, Texas, on July 15,  
5 1947, to F.E. "Bud" and Phyllis Snell, and he grew up with one  
6 sister, Jolene; he shared a rewarding marriage of 51 years with his  
7 wife, Vicki Smith Snell, and he was the proud father of two  
8 children, Traci and Bradley; later in life, he had the pleasure of  
9 welcoming into his family two grandsons, Deakin and Dalton, as well  
10 as a great-granddaughter, Harper; and

11           WHEREAS, Mr. Snell was for many of his early years a cotton  
12 farmer in the small community of Klondike in Patricia, Texas,  
13 spending his days cultivating the fertile land of West Texas; and  
14 later he was a respected member of the Lamesa business community as  
15 a crop insurance agent with Matlock & Associates, and as a real  
16 estate broker for 25 years to his firm, Duane Snell Real Estate; Mr.  
17 Snell and his wife, Vicki, were known to give generously of their  
18 time and financial support to many worthy causes such as the local  
19 school district and several civic organizations; and

20           WHEREAS, Duane was active over the years with his weekly golf  
21 group at Lamesa Country Club where loud laughter, bad jokes, and  
22 golf stories were frequently shared after the day's round; and Mr.  
23 Snell was also known to be an accomplished manufacturer of cigar box  
24 guitars, as well as a bassist in an outlaw bluegrass and country

2 WHEREAS, A devoted family man and a hardworking professional,  
3 Duane Snell lived a rich and purposeful life, and those he leaves  
4 behind will forever cherish their memories of this kind, humorous,  
5 and caring man; now, therefore, be it
