1           WHEREAS, The 90th birthday of a trailblazing entrepreneur is  
2 truly cause for celebration, and Lucious L. Williams of DeSoto  
3 marked this significant milestone in his life on March 16, 2021; and

4           WHEREAS, Born in Clarksdale, Mississippi, in 1931, Lucious  
5 Williams grew up as the second-youngest of nine children; he joined  
6 the Memphis Red Sox in the Negro American League as a teenager and  
7 played second base; in 1979, while living in Milwaukee, Wisconsin,  
8 he launched an engineering company, Dikita Enterprises, using his  
9 car as collateral for a 90-day start-up loan; four years later, he  
10 moved his headquarters to Dallas, where his oldest daughter, Eve,  
11 was attending college, and he persuaded her to become chief  
12 financial officer; he is also the proud father of two other  
13 daughters, Desiree and Sarah, and he shares a fulfilling marriage  
14 with his wife, Rubee Manson Williams; and

15           WHEREAS, Mr. Williams skillfully guided the growth of  
16 Dikita, which is considered the oldest African American-owned  
17 engineering and consulting firm in North Texas; over the course of  
18 more than four decades, it has handled a host of major projects for  
19 such entities as Dallas Area Rapid Transit, DFW International  
20 Airport, the Texas Department of Transportation, and the Dallas and  
21 Lancaster Independent School Districts; it has also provided  
22 transit planning and other services to communities across the  
23 nation; in 2010, he handed the reins to Eve Williams, and he now  
24 serves as chair of the board and director of government affairs; he

1 has given generously of his expertise as the leader of numerous  
2 civic groups, and in his free time, he is an avid golfer; in 2018, he  
3 was inducted into the Texas Black Sports Hall of Fame; and

4 WHEREAS, Respected and admired by all who are privileged to  
5 know him, Lucious Williams may reflect with great satisfaction on a  
6 lifetime of achievement, and it is a pleasure to join in honoring  
7 him on this noteworthy occasion; now, therefore, be it

8 RESOLVED, That the House of Representatives of the 87th Texas  
9 Legislature hereby congratulate Lucious L. Williams on his 90th  
10 birthday and extend to him sincere best wishes for continued  
11 happiness; and, be it further
