1           WHEREAS, Michelle Brewer of Silsbee has been appointed to the  
2 OneStar National Service Commission by Governor Greg Abbott, and  
3 she was named a 2020 Woman of Integrity by the Better Business  
4 Bureau Serving Southeast Texas; and

5           WHEREAS, The commission is the state's liaison to the  
6 Corporation for National and Community Service, and it helps to  
7 oversee the Rebuild Texas Fund for citizens recovering from  
8 Hurricane Harvey; Ms. Brewer is the disaster recovery director for  
9 the Hardin County Office of Emergency Management and further serves  
10 as executive director for Hardin County Strong, which works to meet  
11 the long-term needs of households impacted by disaster; and

12           WHEREAS, Previously, Ms. Brewer was the education foundation  
13 director for Better Business Bureau Serving Southeast Texas, and on  
14 October 22, 2020, she was acknowledged as a Woman of Integrity at  
15 the BBB Texas Professional Women's Conference; the award recognizes

17 with BBB; in addition to her professional efforts, Ms. Brewer  
18 volunteers extensively for many organizations and hometown  
19 projects; and

20           WHEREAS, Ms. Brewer is a member of the national Disaster  
21 Leadership Team, which offers training, mentorship, and support in  
22 establishing a recovery model and effort; moreover, she gives  
23 generously of her time and talents to the children's bus ministry at  
24 First Pentecostal Church of Silsbee; in all her endeavors, she

1 enjoys the support and encouragement of her husband of 31 years,  
2 Charles Brewer, and she takes great pride in their four children,  
3 Chad, Kaylee, Blake, and Dollie, and nine grandchildren; and

6 earned the admiration and appreciation of innumerable people; now,
