1 WHEREAS, An exemplary life dedicated to music and education 2 drew to a close with the death of former Amarillo College professor Dr. Dale Alvin Roller on August 24, 2020, at the age of 90; and 3 WHEREAS, Dale Roller was born to Sylvester and Hattie Belle 4 5 Roller in Cleveland, Oklahoma, on February 1, 1930, and he grew up with four brothers; inspired by two older brothers and his high 6 school music teacher, he studied music at college, earning 7 bachelor's and master's degrees from the University of Tulsa, and in 8 1974 he returned to school to earn a doctorate in music education 9 from the University of Illinois at Urbana-Champaign; during the 10 11 Korean War, he served with the 657th Air Force Band, rising to the 12 rank of sergeant; and WHEREAS, Dr. Roller began his career by teaching piano at the 13 14 University of Tulsa, and in 1956, he joined the faculty of Amarillo College; over the course of his 35-year tenure with the college, 15 16 Dr. Roller taught piano, music history, and humanities, conducted the school's choirs, and rose to become head of the music 17 department; he brought the Suzuki Program to the campus, and he 18 served as one of the college's most charismatic ambassadors, 19

WHEREAS, In addition, Dr. Roller founded the Amarillo Master

persuading countless students across the Panhandle to apply for

admission; after retirement, he served for eight years on the

Amarillo College Board of Regents, including a year as chair, and he

was named professor emeritus in 2005; and

- 6 the University Interscholastic League; from 2012 to 2019, he led
- 7 "The Happy Timers," an ecumenical vocal group for seniors; and
- 8 WHEREAS, In 1956, Dr. Roller was introduced to Betty Jo
- 9 Denman, a violinist for the Amarillo Symphony; the couple were
- 10 married in 1957 and went on to share 60 rewarding years together,
- 11 until her death in 2018; he was the proud father of three sons,
- 12 Scott, Kirk, and Jeff, and later in life he was blessed with seven
- 13 grandchildren and two great-grandchildren; and
- 14 WHEREAS, For more than six decades, Dale Roller was an
- 15 inspiring teacher, musician, and cultural leader in Amarillo,
- 16 bringing the gift of music to his fellow citizens and to generations
- 17 of students, and he leaves behind a legacy that will continue to
- 18 inspire all those who knew and loved him; now, therefore, be it
